This biennial conference, sponsored by the Association of Caribbean Social Work Educators (ACSWE), holds a distinctly prestigious position on the calendars of Social Work educators, researchers and practitioners in the Caribbean Community and its Diaspora. Since 1993, it has been hosted by Institutions that teach and conduct research on Social Work in the Caribbean. Previous conferences have been held in Barbados (1993), Guyana (1995), Trinidad and Tobago (1997), Jamaica (1999), The Bahamas (2001), Barbados (2003) and Jamaica (2005).

### Theme

- Mediation for Caribbean Development

# **Submission of Abstracts**

The Conference Committee invites submissions of abstracts from researchers, educators, practitioners and students whose work focuses on addressing social problems in the

Caribbean and its Diaspora. Both individual papers and entire panel proposals will be considered.

#### **Format**

Presentations may be in the form of papers, posters, panel discussions and workshops. Artistic presentations using film, music, oral and written forms of expression and drama are also encouraged.

Scholarly papers may be considered for publication in the Caribbean Journal of Social Work (CJSW) - a peer reviewed journal that has been published annually by the ACSWE since 2002. Authors wishing to have their papers reviewed for inclusion in the CJSW must submit completed papers by May 26, 2007.

Abstracts should consist of no more than 500 words. Please attach a separate cover page consisting of:
