Scope of Works

Based on minimum design specifications, the successful supplier will be responsible for the design of rings which will need to be approved and accepted by The UWI before the production of the rings.

Eligibility Requirements

- 1. Be qualified, experienced and licensed to deal in precious metals and stones;
- 2. Have **at least 10 years' experience** in the provision of similar rings to schools, universities and other major learning institutions;
- 3. Interested firms must provide evidence of valid NIS Certificates, VAT Clearance Certificates, and Income Tax Clearance Certificates.
