Concept Note and Programme

The fourth International Conference on Small Island Developing States (SIDS4), convened under the theme 'Charting the Course Toward Resilient Prosperity', will be hosted by Antigua and Barbuda on 27-30 May 2024. ([United Nations \(UN\) DESA](#) together with [UN-OHRLLS](#) are coordinating inter-agency [preparations](#) and contribution of the UN system to the Conference.) SIDS4 is an [opportunity](#) for "the international community [to] gather to review SIDS' sustainable development progress and propose a new decade of partnerships and solutions to supercharge their path to resilient prosperity."

In this regard, in reference to SIDS ([comprising](#) 37 UN member nations and 20 associate members of regional commissions), an imperative [call](#) has been made for all concerned to "craft an ambitious programme of action that is robust and achievable. Not a wish list, but an action list."

Accordingly, having regard to their sustainable development and *the* prevailing [multilateral framework](#) to back stop same, SIDS4 is geared towards striking an agreement on a new programme of action for SIDS. As the preliminary outcome for SIDS4 has [come into view](#)—drawing as it does on [preparatory steps](#) and *inter alia* the [SAMOA Pathway](#), [Mauritius Strategy](#) and [Barbados Programme of Action](#)—a large multilateral diplomatic [spotlight](#) is now on SIDS. Moreover, SIDS-related [challenges](#) loom large.

SIDS [are](#) "uniquely and unfortunately positioned at the forefront of multiple global crises, notably climate change." At a time when global leadership on climate has come under [scrutiny](#), and all the while climate change impact assessments [point](#) to the dire implications for SIDS, it is [widely accepted](#) that "for ... the Caribbean, as it is in other [SIDS], addressing climate change is of utmost importance and priority." In fact, in scholarly and practitioner communities, climate change is [recognized](#) as "the defining feature of the Caribbean developmental landscape." Contending that regional states remain on the "[frontlines](#)" of the global climate crisis, [Caribbean Community \(CARICOM\)](#) leaders continue to focus on that crisis and climate impacts, positioning the regional grouping to [exercise](#) leadership on the issue.

CARICOM Heads of Government [recognize](#) that SIDS4 will be an "inflection point" for these sorts of issues to be articulated. This landmark high-level meeting, then, is the object of considerable diplomatic

focus on the part of the bloc. With the foregoing in mind, on **17 May 2024 from 9:30am to 12:00pm Atlantic Standard Time (AST)**, The UWI Institute of International Relations' [Diplomatic Academy of the Caribbean \(DAOC\)](#) will host a hybrid symposium. This symposium is one of a series of DAOC events, carded for May 2024, to mark a decade of delivery of an innovative, modern regional programme on diplomatic training and analysis. It seeks to elicit reflection on Caribbean multilateral diplomacy *vis-à-vis* a multifaceted SIDS agenda, relating to themes of the *SIDS4 Zero Draft Outcome Document*, while focusing on the actors involved, roll-out of attendant processes and expected outcomes. It provides a platform for open, in-depth debate among a cross-section of stakeholders in the Caribbean and beyond.
