From June 26th to 29th, 2018, Ms. Sharon Welsh, Adjunct Professor at Georgetown University and Communications Consultant delivered an excellent training programme at the DAOC entitled "The Art of Corporate and Diplomatic Communication". Ms. Welsh has over 25 years' experience as a communication consultant for diplomatic, political,







military, intelligence, business, and academic audiences. She has taught at the U.S. Department of State's Foreign Service Institute (FSI) for over 25 years. At FSI, Ms. Welsh has taught courses to U.S. diplomats from the Ambassadorial-level to entry-level envoys.

At the Opening, Ms. Mary-Ann Richards, Manager of the DAOC, reiterated the mission of the Diplomatic Academy to provide high-quality, practical training in topics relevant to the 21st Century professional, and the importance of developing one's communication skills.

Ms. Welsh covered topics such as Adapting to cross-cultural audiences; Writing for persuasive effect; Speaking with competence, credibility, and control; Using social media appropriately and Serving as a corporate and diplomatic representative.



As highlighted by Ms. Welsh, "The power to influence, to effectively engage, and to form productive partnerships with others, are closely linked to the ability to connect with audiences in a positive manner. Not only must messages be clear and persuasive, they must be delivered in a manner that conveys credibility. Corporate and diplomatic communication involves message clarity, in both speaking and writing, coupled with a positive perception of the communicator and his/her organization."

Diplomatic Dialogue entitled "Issues relating to the Rule of Law in Venezuela"

On May 18th 2018, Mr Carlos Ayala Corao, Vice President of the International Commission of Jurists delivered a Diplomatic Dialogue at the IIR, entitled "Issues relating to the Rule of Law in Venezuela". Mr Ayala began his presentation with a brief summary of some recent political and socio-economic Venezuela. highlighting developments in difficulties of the oil sector, hyper-inflation, shortages of food and other essential consumer goods and of the deadlock as some political defining characteristics of the crisis.

He outlined the architecture and processes of the Inter-American Human Rights system and the United Nations Human Rights machinery before discussing their principal areas of engagement with Venezuela. He summarized the major findings of the reports and the legal opinions that had been issued by the human rights institutions concerning various developments in Venezuela.

Mr Ayala Corao urged respect for and compliance with the 1999 Constitution of the Bolivarian Republic







of Venezuela.

In his view, the key to resolving the current crisis lies in respecting human rights and the rule of law, political dialogue and political participation, appointing judges, a national prosecutor and the attorney general all in accordance with the current Constitution. He remained optimistic that democracy and the rule of law could be re-institutionalised by the Venezuelan citizens themselves through the holding of free and fair elections. He also called for neighbouring countries to be mindful of the human rights of Venezuelans and to provide humanitarian support where possible.

Presenter's Profile



Carlos Ayala Corao, Vice-President of the International Commission of Jurists

Carlos Ayala Corao was elected as Vice-President of the International Commission of Jurists in 2018 and is currently serving his second term as Commissioner following his election in 2012. He member of the Inter-American was Commission on Human Rights (I-ACHR), serving as Chairman between 1996 and 1999. Mr. Ayala Corao was also the Rapporteur for Indigenous People's Rights of the I-ACHR between 1996 and 1999. He was a member of the Andean Commission of Jurists between 1992 and 2009, serving as their President between 2003 and 2009.

Mr. Ayala has also served as a Professor at a number of prestigious universities, including Universidad Católica "Andrés Bello" (UCAB) and Universidad Central de Venezuela (UCV) in Caracas, Georgetown University and American University in the USA, and has recently been appointed to the University of Oxford in the UK. He is the author of several publications relating to Constitutional Law, Administrative Law and Human Rights Law. Carlos is currently a partner in the Caracas law firm Ayala, Dillon, Fernández & Linares (Consultores Jurídicos).
