Research Tip

The Working Title

"The title summarizes the main idea or ideas of your study. A good title contains the fewest possible words needed to adequately describe the contents and/or purpose of your research paper."

- Be clear and concise
- Indicate the subject and scope of study
- Avoid abbreviations
- Use words that give an accurate impression of the study while stimulating reader interest
- Use current nomenclature for the area of study
- Avoid using terms such as "the study of" or "an analysis of"
- Use correct grammar (the exception when quoting direct speech) and capitalization throughout the title
- If a quote is used be sure to cite the source
- The length should be limited to 10–15 words
- It is important to note that the Final Title is usually written after the research is completed and the writer understands what was studied and the process it took to complete
