Evaluating information sources

While using databases:

Look at title, keywords/descriptors, abstract

Publication in hand:

Authority: author's credentials, publisher, detailed bibliography, peer-reviewed journal, www - author, host

Scope: national / international, detail / overview, new information / confirm previous information

Currency: date, 1st or revised edition
