RESEARCH TIP

Resources and Conclusion

Though using multiple resources may be common knowledge. One must be sure to not disregard sources that seem to relay the same information as your first. Sometimes articles that are 95% the same can hold crucial differences and unique perspectives that one may need for their topic. This may be very tedious, but in the long run it is very effective.

Finally, one must be aware of their ability to succinctly summarize all of this information. When writing an empirical social science research paper its structure is fairly simple and straightforward. Laying out your research in this manner can make things easier to read and easier to write, summarizing your work and findings in a way that others can interpret and quickly evaluate. Optionally, you can provide some direct conclusions at the end of the paper. These are your take-aways, make sure they sum up what you want readers to get out of your paper.
