OVERVIEW OF THE INSTITUTE

The Institute of International Relations (IIR) is a regional post graduate academic institution at The University of the West Indies, St. Augustine Campus. Established in 1966, the IIR was the brainchild of the first Prime Minister of Trinidad and Tobago, Dr. Eric Williams. In light of the recent independence of Trinidad and Tobago and other Commonwealth Caribbean territories, Dr. Williams saw the need for a research oriented and training institution that would provide policy advisory services as well as diplomatic training for public officials of the region.

The IIR is the Caribbean's premier post-graduate educational institution in the field of international relations. Since its founding, the IIR has been dedicated to the conduct of advanced research and post graduate teaching concerning the international challenges of the contemporary world, providing policy research and advisory services and consultancies, public briefings and other forms of engagement concerning the evolving global political economy and global order. Special emphasis is placed on understanding the geopolitical, developmental and multilateral issues facing the Caribbean and Latin American regions.

The Institute has become a key component of the Caribbean's intellectual capacity repertoire and is today recognized as a hub for specialized knowledge in Caribbean international relations. Accordingly, across the Caribbean, the IIR's work is critical to the achievement of broader economic and human development goals. Consequently, the Institute has been integral to the development of post-independence foreign relations and nation-building in the region.

The IIR's mission, to apply multidisciplinary lenses and perspectives to broadening an understanding of the Caribbean's role in international relations, is intended to bring to fruition its vision of developing an expert international relations workforce to provide the region's public and private sectors with the intellectual capacity and skills to effectively navigate a complex international landscape.

In addition to its Postgraduate Diploma, M.Sc. and MPhil/PhD programmes, the Institute of International Relations, through the Diplomatic Academy of the Caribbean (DAOC), meets policy related policy regional and national human resource development needs by offering short intensive modular training programmes for public and private sectors, and civil society personnel.

The IIR is home to the Norman Girvan Library, an expansive repository of research and scholastic material on international relations of the Caribbean and an indispensable feature of the Institute's teaching and research infrastructure.

Since its establishment, the IIR has built up an alumni base of over two thousand professionals, many of whom have distinguished themselves in their careers in the international organizations, national public or private sectors or with other civil society organizations. There is a very distinguished cadre of diplomats/retired diplomats and international civil servants, legal professionals and parliamentarians from the Caribbean who graduated from the IIR at some point in time.

MISSION OF THE INSTITUTE

The mission of the Institute of International Relations is to enhance understanding of Caribbean international relations, applying multidisciplinary perspectives, while contributing to related

regional and national human resource development. The IIR offers excellent research, teaching and consultative assistance to diverse stakeholders. The Institute organizes, sponsors and cosponsors workshops, conferences, and seminars relevant to the international relations related challenges of the region and is the institutional home of the <u>Caribbean Journal of International Relations and Diplomacy</u>.

VISION OF THE INSTITUTE

The IIR brings together the expertise and energies of all the international relations academic staff within The University of the West Indies, as well as those of selected Associate Fellows located elsewhere, to respond to the needs of the Caribbean region's public and private sectors for research, teaching, consultancy and training, concerning the region's international challenges and opportunities, within multidisciplinary fields ranging from finance, business and management to politics, history, economics, education, and law.

GOVERNANCE OF THE INSTITUTE

The governance of the Institute is vested in the Board of the Institute, which is chaired by The University of the West Indies (UWI) Vice Chancellor. The management of the Institute rests with the Director, who is responsible to the Board for the proper discharge of the Institute's functions.

Interim Director's Annual Report 2022 - 2023

Period: August 01st 2022 to July 31st 2023

DIRECTOR SUMMARY

The academic Year 2022/2023 was significant in the history of the Institute of International

Relations. The major matters dominating the agenda of the IIR include:

1. Budgetary Matters

In 2019 – 2020, the budget of the IIR was dramatically reduced by 90 percent to one million

TTD. In the approved budget estimates for 2020 - 2021, the funding was further reduced by

10 percent to 900 TTD. The Institute managed on its savings and reserves until December

2022 by which time this had been exhausted.

Importantly, informal consultations took place between IIR and Trinidad and Tobago

government actors, specifically the Minister of Foreign and CARICOM Affairs and the

Minister of Finance and follow-ups with the Minister of Education. Deepest gratitude to IIR

staff who contributed directly and indirectly to the lobbying efforts. This was consolidated by

the formal interventions of Professor Rose-Marie Antoine, Principal and Pro-Vice Chancellor

of the St. Augustine Campus with the Ministers of Finance and Education on the restoration

of funding to the IIR. We wish to thank Professor Antoine for her support of the Institute.

We are also very grateful to our Dean, Dr. Acolla Lewis-Cameron for her advice and support

of the IIR's efforts throughout the process.

Noteworthy, is the receipt of correspondence, dated 6 February, 2023 from the Minister of

Education, based on the Minister of Finances' directives that the IIR's allocation would be

increased to \$TT9 million for the year 2023. Despite this announcement, and the interim

financial provisions which had been made for the IIR by the UWI St. Augustine Campus, the

IIR continued to be financially conservative in its spending during the reporting period.

2. Processes related to the Vice-Chancellor's Task Force to discuss the way forward for the IIR.

A Task Force was mandated by Vice-Chancellor Sir Hilary Beckles on July 25, 2022 to discuss and chart a way forward for the IIR, in light of its severely depleted funds. At its first meeting of August 26, three working groups were set up to discuss the details for the work of the Task Force. Task Force and Working Group meetings lasted from August 2022 - March 2023. The main agenda of Working Group One was to deliberate on the structure and management of a "Centre", the governance structure recommended for the IIR by the Task Force, at its first meeting.

A stakeholder consultation was conducted with both internal and external actors in partial fulfilment of the mandate of Working Group (WG) One. The main objectives of this exercise were to identify gaps and needs in the market for the IIR and to suggest funding options and ideas for revenue generation. All interviewees were familiar with, and had varying degrees of involvement in the affairs of the IIR. They also had sound experience, knowledge/expertise, and prolific careers in the field of International Relations. Unquestionably, all interviewees agreed on the significance and importance of the Institute to The University of the West Indies and beyond. They also noted that the IIR has a competitive advantage in the areas of international studies, foreign policy, and diplomacy, compared with similar institutions in the region. However, it was noted that the regional profile of the IIR had been eroded over time.

The deliberations of Working Group One drew heavily from the findings and recommendations of the 2021 Quality Assurance Review (QAR) report, including the restoration of the government subvention, at least in the short term. The findings of the stakeholder report were also reflected in report of Working Group One. The Working Group recommended that the restoration of funding should be prioritised because new or revised governance arrangements would not solve the funding challenge. Simultaneously, the restructuring of the IIR should be aligned with the recommendations of the QAR report, including exploring alternative sources of funding and revenue generation.

Working Group Two (Human Resource Review) proposed two scenarios for the IIR's restructuring: Scenario One, aimed at adjustments for greater efficiency and Scenario Two, mirroring the "Centre" governance structure, encompassing a significant scaling down of the IIR.

Based on the recommendations of both Working Groups and the pledge from the Government of Trinidad and Tobago to provide the IIR with 9 million TTD for 2023, the Task Force deliberated and made some recommendations on the following areas: The IIR's governance structure, including the membership and operations of the Board of Directors; the relationship between the IIR and the DAOC; and the IIR's overall operations, including revising/readjusting certain job specifications.

3. IIR's revised programmes

The IIR maintained full delivery of its three academic programmes and the award of its postgraduate diploma, M.Sc. and PhD degrees. Notably, three PhDs were awarded in the 2022/2023 period.

The IIR's taught programmes underwent a major review which occurred over the period of over four years, receiving approval in May 2022. Among the major revisions include: the Post Graduate Diploma in International Relations was changed to a Post Graduate Diploma in International Relations and Global Studies; The MSc. in International Relations was re—introduced and offered alongside the MSc. in Global Studies. An important innovation in the revised curriculum is the opportunity for Post Graduate Diploma students to transition to either of the MSc. programmes after the first semester, having met the requirements. The MSc. programmes will be completed in three semesters rather than two in the previous dispensation. The rationale for the latter is to allow additional time to produce a quality research paper. Following the approval, the IIR spent a significant amount of time and resources fulfilling the various administrative requirements for the implementation of the revised programmes which began in September 2023.

4. Public Outreach, Research and Profile

This period was marked by a high number of public events, in-person and online modality of various types, including Diplomatic Dialogues, panel discussions, symposia, special guest lectures among others. These were largely done in partnership with regional organizations, high level officials, the Diplomatic Corps, the private sector, academic institutions, other UWI departments and alumni. There was enthusiastic response from public officials, individuals, alumni and the Institute's regional and international networks. This gesture continues to raise the IIR's visibility as a national and regional repository and distributor of knowledge, and helps to attract new local and international students in the following year.

The IIR's participation continued in the international collaborative research project on Climate Change and Community Responses (via the work of Dr. Michelle Scobie). Also, of note is its strategic partnership with the Caribbean Policy Consortium (CPC), a network of academics, policy advocates, public officials and private sector representatives from North America and the Caribbean who work to strengthen United States-Caribbean relations and raise the visibility of Caribbean development concerns in the partnership.

Academic staff have continued to produce high quality and relevant academic and technical publications, and to partner with international organizations and other local and regional entities in preparing technical reports, policy briefs and providing expert advice geared to address the multiple challenges facing the Caribbean and the global community. They have all contributed their expertise to a wide range of online discussions, public lectures and academic conferences.

Importantly, the latter part of the reporting period saw the IIR re-gaining momentum after a period of uncertainty, upheaval and the COVID 19 Pandemic. In sum, the IIR is confronting the current era with determination, energy and a focus on renewal in all its activities.

5. Diplomatic Academy of the Caribbean

With regard to implementation of its a primary teaching mandate in the area of diplomatic studies, spanning the period August 1, 2022 to July 31, 2023, the DAOC delivered five (5)

online training modules. As regards its secondary outreach and advocacy-related function on the nexus between the Caribbean and diplomacy, by way of a series of the Manager's published works during the said period, the Diplomatic Academy focused particular attention on contributing to and engaging in practitioner and scholarly debates on the ever-evolving geopolitical and international environment.

Appointments, Promotions, Departures and Resignations

Staff Appointments and Departures

There were no new full-time teaching appointments in 2022/2023. However, part time appointments were awarded to three colleagues to lecture as follows: Dr. Indera Sagewan (INRL 6004, Semester I and INRL 5007 in Semester II); Dr. Madgerie Jameson-Charles (INRL 6020 in Semester I) and Dr. Priya Marajh (INRL 6001, Semester I and INRL 5002 in Semester II). The IIR appreciates their contributions to the quality of its courses and the experiences of the students.

Dr. Lancelot Cowie, founding Head of the Centre of Latin America and the Caribbean was appointed as Honorary Professor of Latin American Studies in April 2023 for a period of two years. The IIR welcomes Dr. Cowie and we look forward to his contribution towards the expansion and diversification of the Institute's offerings and engagements on Latin America issues.

Miss Unika Omowale was seconded from the Alma Jordan Library as a Librarian Grade One to direct the Norman Girvan Library *ad interim* following the retirement of Mrs. Cherril Farrell in AY 2020/2021. Ms. Omowale remained in that role in 2022/2023 and in February 2023 Ms. Omowale continued to steer the library through this academic year with quiet dedication to duty, efficiency and collegiality. We are grateful for her contribution, and we acknowledge the sterling support of the Campus Librarian in facilitating her placement at the Norman Girvan Library and her fixed appointment.

Mr. Daniel Baboolal was reassigned from the Human Resources department to the IIR as a Grade 2 Office Attendant with an additional responsibility allowance to replace Mr. Zaahir Hamid, Grade

6 Technical Assistant I, for the period May 01, 2023 to September 08, 2023. Mr. Baboolal brings much needed support to Mr. John Maloney in facilitating IIR/DAOC training and public events. We welcome Mr. Baboolal to the IIR and wish him a fruitful and enjoyable experience with us.

Following a series of renewal of assignment contracts for Miss Wenda Rocke since 2021, from the Dean's Office, Faculty of Humanities and Education, Miss Rocke was laterally transferred to the Institute of International Relations effective April 1, 2023.

Over the course of the academic year, there were 3 departures from the IIR, reassignments to other UWI departments: Miss Zara Weekes-Rhyzer, Grade 7 Secretary to the Human Resources Division (Appointments Section); Miss Marissa Diaz, Grade 6 Clerical Assistant III (DAOC) to the University Office of Research; and Mr. Zaahir Hamid, Grade 6 Technical Assistant I to the Faculty of Sciences and Technology.

Dr. Michelle Scobie, proceeded to no pay leave for a six-month period, effective January 15, 2023. Drs. Michal Pawinski and Nand Bardouille went on full study leave, for one out of the three months (April 1 to 30, 2023) and three months (January 9 to April 13, 2023), respectively.

Promotions, Staff Training and Development

Promotions

Dr. Jacqueline Laguardia-Martinez was promoted to the rank of Senior Lecturer with effect from January 01 2023, Dr. Michal Pawinski crossed the merit bar with effect from August 1, 2023 and Dr. Georgina Chami was awarded indefinite tenure with effect from August 1, 2022. The IIR congratulates colleagues on their well-deserved achievements.

Staff Training and Development

Academic, and Administrative, Technical, and Service Staff engaged in several training and professional development exercises. These included the A.D.V.A.N.C.E Programme hosted by the Faculty of Social Sciences in semesters one and two, commencing from November 3, 2022. Staff who participated were Marion Bailey, Chinelle Chadee, Liu Joseph, Harriett Modeste, John

Maloney and Michelle Seeraj (IIR Secretariat) and Premma Ramsawak, Gina Ravello and Malika Charles (Norman Girvan Library).

The IIR Secretariat staff participated in other sessions, for example, COVID 19 Training for Cleaners (Marion Bailey); Emergency Management and Fire Extinguisher (Chinelle Chadee and Liu Joseph); Mindfulness-Based Stress Management (Wenda Rocke and Liu Joseph); Train the Trainer for OJTs (Wenda Rocke).

The Norman Girvan Library staff engaged in the following training exercises: CETL Cool Tools in Education (Premma Ramsawak and Malika Charles); Mould Remediation: Preservation Training for Staff of Campus Libraries (Gina Ravello and Malika Charles); and What You Need to Know About Copyright, by the Intellectual Property Office, Trinidad and Tobago (Malika Charles); Warden Training (Malika Charles); Dr. Michal Pawinski completed the teaching software training: FeedbackFruits Training Series: Increasing Interactivity in online and hybrid course design and UWI Online Short Courses in Mathematics and Statistics, SPSS Beginner and SPSS Intermediate.

Staff Research Output and Scholarly Activity

During academic year 2022/2023, eight academic staff members accounted for 29 publications, out of which 15 were peer reviewed, as illustrated in the table below. Academic staff members made 33 presentations at conferences, webinars, seminars or public lectures and moderated at 6. Details can be found in **Appendix I**.

STUDENT MATTERS

Registration

There was a slight increase in overall student registration from 67 (2021/2022) to 72 (2022/2023), however, considering the withdrawals in this period, enrolment this year is lower. Many cited personal constraints and work commitments for their inability to cope with the programme. Possible explanations for the general low registration lie in the adverse economic and social impacts of the pandemic which have negatively affected individuals and households. The removal of the Government of Trinidad and Tobago 50 percent GATE fee subvention for its citizens pursuing graduate programmes at tertiary institutions may have also decreased students' capacity to access post graduate education.

The figures illustrate that students continue to be overwhelmingly from Trinidad and Tobago, with about 10 percent being from the region and other parts of the world. Though very few, it is noteworthy that regional and international enrolment has increased from previous years due to teaching via virtual modes. This consideration must inform policy-making on future programmes, their delivery modes and target markets.

The IIR heartily congratulates all graduating students. We wish them all the very best in the future and we hope for continued engagement with them as valued members of our alumni network. Special mention must be made of Dr. Lisa Gordon who published her PhD work only one year later with Routledge, a top-tier publisher. Preparations are being made for the PhD Viva of Ms. Candia James. Dr. James was awarded on September 29, 2023.

Staff/Student Liaison Committee: Student Feedback

During the last Academic Year, the Staff/Student Liaison Committee met twice: November 2022 and April 2023. The Committee is made up of 6 persons. It is chaired by Dr. Keron Niles, IIR Faculty. One member of the Secretariat and Library are represented, with one student each from IIR's 3 programmes. The comments of students at the two meetings are as follows:

Inability to/Difficulty Accessing Journal Articles The library has indicated that students can use the document delivery system to retrieve articles that may be difficult to access.

2. Mode of teaching

Students expressed appreciation for the continuation of online classes and the ease of access especially for those from overseas. Similar views were shared last year, including for students in distant parts of Trinidad.

3. MPhil/PhD student supervision

PhD students stated concerns of feeling isolated from their supervisor on their PhD journey. This matter will be addressed in the new academic year with regular meetings for MPhil/PhD students to discuss their concerns and develop a sense of community. Seminars to assist them on their PhD journey will also be convened.

4. Academic achievement of IIR graduate

They sent congratulatory messages to Dr. Lisa Gordon (PhD 2022) who launched her book entitled "International Trade and the Music Industry: Live Music Services from the Caribbean" on April 28, 2023 at the IIR.

Programme Marketing and IIR Visibility

The IIR academic and administrative staff are cognizant of the ever-increasing importance of marketing the IIR and DAOC programmes and events, especially with the declining numbers during the COVID pandemic and in the immediate post COVID 19 era. The advertisement of public lectures and webinars is executed by Marketing and Communications and by dissemination through the IIR and DAOC networks and mailing lists.

Based on these findings, a key recommendation is the urgent need to update and redesign the IIR website. The IIR is in the processes of sourcing an Associate Professional through the Ministry of Education, Scholarships and Advanced Training Division for one year to re-design the IIR website. In the interim, the IIR expanded and increased the dissemination of programme information throughout the Caribbean region utilizing the IIR's institutional and alumni networks as well as the channels in Trinidad and Tobago, including via the IIR and NGL websites and social media pages, print and radio/television media. Attractive brochures were sent to various Government Ministries of CARICOM countries and beyond and to the IIR's expanded mailing list.

Curriculum Review

Part of 2022/2023 has been spent tying up the loose ends (such as approval for two new courses) and putting the administrative requirements for the implementation of the revised diploma and MSc programmes for AY 2023/2024. The revised programmes have several innovations. First,

the Post Graduate Diploma (PGD) in International Relations has been converted to a PGD in International Relations and Global Studies. This change was to resolve the dilemma of having a PGD in international relations yet a Masters in Global Studies and not international Relations. Second, under the old programme, one of the requirements for entry into the Masters programme was successful completion of the PGD in IR. With the revised programme, a student has the option of "transitioning" to the MSc in International Relations or MSc In Global Studies after the first semester if an A average is maintained. Third, two Masters will now be offered: re- introduction of MSc in International Relations and continuation of MSc in Global Studies.

We are grateful that the process is completed and students applied for the revised programmes. The IIR is very grateful for the sterling contributions of Dr. Michelle Scobie, Chair of the Curriculum Committee for three years and Dr. Dave Seerattan who took over during her study leave. The IIR also wishes to acknowledge the contributions of the Diploma and Masters programme coordinators, respectively, Drs. Georgina Chami and Michal Pawinski for their input. We are also grateful for the hard work of Miss Wenda Rocke and Ms. Usha Lakhan for administrative support. The IIR also received tremendous support from the Director and staff of the Office of Graduate Studies and Research, CUTL Programme Coordinator Dr. Justin Zephyrine of CETL and Dr. LeRoy Hill, Director of CETL. It is important to note that the revisions of the PG Diploma and MSc Programmes are closely aligned with many recommendations made in the Quality Assurance Review Report of the IIR which was delivered in March 2021.

IIR Post Graduate Certificates, Multidisciplinary Certificates and Short Courses

The IIR conducted a survey to determine which courses should be packaged as IIR post graduate certificates and multidisciplinary certificates (a combination of courses from the IIR and other departments); and areas in which short courses should be developed. The survey was completed and analysed and Dr. Keron Niles led in the development of a post graduate certificate with the support the IIR Secretariat.

Latin American Studies Programme

The IIR has two courses on Latin America on its books and only one was being taught. An expanded Latin American Studies programme is envisaged at the IIR, in line with the original

scope of the Institute 's programmes to focus on all aspects of international relations, with specific emphasis on Caribbean and Latin American Studies. Justification for such an initiative can also be found in the recommendations of the 2021 Quality Assurance Review (QAR) Report that the IIR should become the hub for specialized knowledge and expertise in the discourse and practice of Caribbean and Latin American diplomacy. It is on the basis of the above that Dr. Lancelot Cowie, founding Director of the Centre of Latin America and the Caribbean (CENLAC), was brought in to contribute to the expansion of Latin American Studies at the IIR. The IIR hopes to expand and consolidate its networks in the academic and policy spheres in Latin America and Caribbean frameworks through this programme.

Teaching and Learning, Curriculum Enhancement

Teaching and learning enhancement has been provided via the diverse public events and in-course guest lectures by practitioners and experts in various fields which were offered by the IIR. The DAOC training modules offer professional development beyond the classroom. Internships are another avenue through which students can receive additional professional training. In the second semester of the academic year, efforts were made towards revamping the internship programme. With the help of a OJT Ms, Maryam Ali- Khan, the internship data base was expanded and updated, and letters sent to organisations to secure regular internships in the new academic year. The objective was to establish formalised arrangements with participating organisations to guarantee annual internships for our students.

Following travel bans and COVID restrictions, overseas and local student study tours were discontinued. Local study tours were reinstated in the reporting period, under the direction of Dr. Jacqueline Laguardia Martinez. Attempts were made to organise a study visit to Guyana and Suriname with the assistance of Dr. Mark Kirton. However, very few students showed commitment to the trip. This could have been caused by the lack of solidarity among students to mobilise fund raising because of online teaching, awareness of reduction of sponsorship and donor funding in the marketplace and general economic hardship from the aftereffects of COVID.

Dr. Georgina Chami continued her work as Faculty Advisor for the UWI STA Model UN Club in 2022/2023. While this club attracts a mainly undergraduate membership, it offers tremendous

developmental benefits to the students. The group did not participate in HNMU 2023 because of lack of funding. However, the interest in the club did not wane. The number of meetings increased from weekly to bi-weekly due to increasing student demands. The activities of the academic year focussed on aspects of a Model UN conference, including writing position papers, clauses, raising awareness on issues related to the United Nations' Sustainable Development Goals such as trade and the economy, global security, geophysical and environmental issues. Meetings also addressed a wide range of topics relating to the UN and its functions. The leadership of the UWI MUN activities here since 2018, is one of the many ways in which the IIR adds value to the St Augustine Campus. Dr. Chami is to be commended for all the hard work she has put into developing this Club and nurturing the undergrad students' development as well-rounded Caribbean citizens.

IIR's Public Outreach Events

The IIR hosted/co-hosted and organised a total of 21 public events to July 31, 2023 as illustrated in table 1 below:

These events are intended to promote discussion and exchange of ideas with government officials, practitioners, experts, students and the general public on issues of relevance to international relations and regional development. Importantly, the events give the IIR's work a regional reach, promote its public presence, generate knowledge and advance the policy relevance of its work. Many of these events are executed collaboratively with individuals and a wide range of organisations, including, research and policy bodies, think tanks, national and regional governmental and non-governmental organisations. These partnerships highlight among many things, the multidisciplinary nature of the IIR's work and its ability to bridge the gap between theory, policy and practice.

While all the seminars are important for the reasons mentioned above, special mention must be made of the two "CARICOM at 50" events to commemorate CARICOM's 50th anniversary,

organised in collaboration with the CARICOM Secretariat — (i) a symposium and (ii) a youth forum, at which the keynote speakers were Dr. Carla Barnett, CARICOM Secretary General and the Honourble Kerryne James, Minister for Climate Resilience, the Environment and Renewable Energy of Grenada, respectively. Honourable Kerryne James, is perhaps the youngest elected member of Parliament in the CARICOM region. The Minister of Foreign and CARICOM Affairs, Senator the Honourable Amery Brown and the Dean of the Faculty of Social Sciences, Dr. Acolla Lewis-Cameron delivered remarks. Other speakers at the symposium were among the most notable scholars and best placed practitioners in the region in the area of regional integration. The participants at the youth forum included representatives of the various chapters of the UWI Guild of Students as well as those from regional youth organisations.

Latin American Forum (in Spanish)

Among the initiatives of the Latin American Studies Programme is a Spanish Language Latin American Forum, launched on Thursday 27th April, 2023. The Forum builds on the earlier activities of CENLAC from 2003 to 2016. The meetings of the Forum consist of presentations on relevant historical, political, economic, social and international relations issues in the Latin American context. A wide cross selection of society attended the inaugural session, including Ambassadors from Mexico, Venezuela, and Brazil, as well as diplomats from the embassies of Panama, Chile, Argentina and the Dominican Republic.

The Ambassador of Mexico to Trinidad and Tobago, H.E. Víctor Hugo Morales Meléndez presented the inaugural lecture entitled: **Francisco Villa, Vida y hazañas de una leyenda**, on Thursday May 18, 2023 at 2:30 p.m. Following this inaugural meeting, there were two Latin American Forums in the reporting period. Presentations were delivered by the Ambassadors of Mexico and Peru.

Other events on issues of high public importance and/or which generated significant interest were on the Haitian Crisis in collaboration with the Caribbean Policy Consortium, the war in Ukraine, in partnership with the EU Delegation to Trinidad and Tobago, challenges and solutions around the repatriation and reintegration of Trinidad and Tobago nationals in Syria, with the International

Parliament for Human Rights and reflections on Climate Change and COP27, in collaboration with the Arthur Lok Jack School of Business.

Noteworthy are the 3 book launches, which generated rich discussions and commentaries.

It is important to acknowledge that the public events were led/co lead by various IIR Faculty with the support of the IIR Secretariat as follows: Annita Montoute and Jacqueline Laguardia – Martinez (Two CARICOM at 50 events); Jacqueline Laguardia Martinez (Cuba - CARICOM Relations; The 210th Anniversary of the Chacachacare Expedition that Liberated Eastern Venezuela in 1813; and Kari Polanyi Levitt: Celebrating a True Caribbean Woman); Annita Montoute (The War Against Ukraine: How Will It End?; Soft power or hard power is the European Union a positive player in global security; The Haitian Conundrum: Challenges and Opportunities; Dynamics of Africa-Caribbean Engagement; and Taking the Profit out of Illicit Trafficking of Firearms in Latin-America and the Caribbean); Keron Niles, (COP 27: the need for unified Caribbean leadership) Michal Pawinski, (Repatriation and Reintegration of Syrian Refugees) Dave Seerattan,; (Cryptocurrencies and the Caribbean) and Professor Lancelot Cowie (Latin American Forum meetings).

We are grateful to Faculty who either took the initiative and/or agreed to lead the planning of IIR public events. As all the above events were delivered in collaboration with various organisations and individuals, the staff assisted in sustaining and/or expanding the IIR's networks and partnerships.

We are hoping to expand the IIR's outreach to regional governments and further integrate the DAOC and the IIR by offering specific needs driven capacity building workshops. We envision these to be delivered via the DAOC and planned and taught by IIR Faculty.

Quality Assurance Review Report Follow-Up

The Implementation Plan following receipt of the 2021 Quality Assurance Review Report was completed last year and is awaiting further direction and feedback from the Board. The Plan addresses key recommendations made by the Assessment Team. Some of the recommendations are already being implemented as they were closely aligned with the IIR's Curriculum revision exercise. Importantly, many of the recommendations of Working Group 1 of the Task Force on the restructuring of the IIR mirror that of the Quality Assurance Review Report.

IIR's Collaboration and Partnerships

The IIR continued to build on its networks and partnerships in the reporting period. This year the IIR and the WTO collaborated to establish and manage the Regional Trade Policy Course after a three-year hiatus due to the COVID pandemic in 2020 and 2021 and low registration in 2022. For the second time, from 17 July to 8 September, 2023, the two parties provided an eight-week Regional Trade Policy Course for selected participants from Caribbean Members and Observers of the WTO. Dr. Dave Seerattan served as the UWI Coordinator. Dr. Indera Sagewan-Ali was the Academic Coordinator and the IIR Secretariat provided administrative support.

Our collaborators for seminars and public events, included: foreign embassies in Trinidad and Tobago (Mexico, Peru, Venezuela and the EU Delegation of the European Union, France), Caribbean Policy Consortium, The International Parliament for Human Rights (Parlamento Internacional para los Derechos Humanos, PIDH), American Chamber of Commerce, American Bar Association (ABA) Criminal Justice Section, Institute of Global African Affairs, University of Johannesburg Trinidad and Tobago; Arthur Lok Jack School of Business, CARICOM Secretariat, Republic Bank Trinidad and Tobago, Central Bank of Trinidad and Tobago, UWI Guild of Student Chapters, various regional youth organisations, United Nations Development Programme, Pointe-a-Pierre Wildfowl Trust, The H-Empire of H-Net, China Institute of International Relations and Centro de Estudios del Caribe: Casa de Las Americas. We also collaborated with individuals including Professor Jorge Heine and our own Alumna, Dr. Lisa Gordon.

In keeping with the QAR recommendation that the Institute should expand its partnerships with foreign universities and international organisations to boost the IIR's capacity and research productivity, we sought to purse such engagements. These include the University of Johannesburg Institute for Pan African Thought and Conversation (IPATC) in the context of the joint UWI/UJ Joint Institute. The IIR hosted a delegation of staff and student from the University of Johannesburg's Institute for Global African Affairs (IGAA) Delegation, January 20 – 28, 2023. During the visit, the IIR and IPACT agreed to collaborate on several initiatives, including staff exchange, joint research and funding, supervision, seminars and publications. Depending on funding availability, IIR staff will be invited to visit the IPATC and a joint edited book project is underway between the IIR and IPATC. Dr. Annita Montoute (IIR) and Dr. Adeoye Akinola (IPATC) are co-editors of the Pan African Conversations: An International Journal, the flagship publication of the IPATC.

The IIR finalised an MOU with the China Institute for International Studies (CIIS) in December 2022. It was due to be signed during an IIR-CIIS large scale webinar which was to have been held on 19 and 20 December 2022. This webinar was postponed, due to severe COVID conditions in China, resulting in the delay of the signing of the MOU. The CIIS and IIR have discussed having a scaled down version of the webinar and signing of the MOU during the meeting. The MOU aims to facilitate joint research activities, exchange of faculty members and research students; staging of joint seminars, meetings and conferences; mutual participation of fellows and researchers in the events of both parties, exchange of academic publications and related materials and collaborative academic programmes which may involve cultural activities.

Dr. Pawinski and colleagues at Ming Chuan University of Taiwan have been delivering guest lectures to each other's classes. Dr. Laguardia has also been invited to participate. This has led to discussions between the two institutions to formalise the relationship. An MOU was finalised by the UWI Legal Department between the IIR and the Ming Chuan University of Taiwan. The MOU permits collaboration in the following areas: research and research funding, supervision, staff and student exchanges, information sharing about conferences, workshops, assistance to participate in each other's events, supporting activities/ services such as language training and orientations and preparatory courses.

The IIR continued to engage in EU-LAC Partnership forums and meetings hosted by the Carolina Foundation and the EU-LAC Foundation. Dr. Annita Montoute participated in the meeting of Research Centres and Study Associations based in Latin America and the Caribbean dedicated to the analysis of the European Union and Bi-regional Relations between Europe and Latin America and the Caribbean, in December 2022. Dr. Jacqueline Laguardia Martinez participated in the Dialogue between European, Latin American and Caribbean Research Centres and Decision Makers: Perspectives and proposals to renew the Strategic Association between the European Union and Latin America and the Caribbean, in Madrid Spain, April 2023.

IIR Alumni Association (IIRAA)

The IIR Alumni Association (IIRAA) was established last year, and this academic year registered as a professional sub-chapter of the St. Augustine Campus UWI Alumni Association. The IIR boasts over 2000 alumni, many of whom have had or are presently developing outstanding careers in international and regional organizations, national public life, private sector bodies and civil society development and advocacy spaces. A key strategic goal of the IIRAA is to institutionalize their relationship with the Institute and further harness their support and collaboration in building the Institute, while especially for younger alumni, supporting their ongoing professional development interests.

The alumni are a tremendous asset and source of pride to the IIR and we are committed to supporting the IIIRA in their objectives and endeavours. On the IIR website, we have removed the Alumni page as a sub-tab and placed it as a main tab to give it a more prominent position. A contact form has been created for Alumni to provide their updated information for the purpose of updating the Alumni database and mailing list to facilitate more widespread and further engagement with members. A note has been sent to alert members and to ask them to pass on to those whose emails have changed and are not receiving notifications of IIR events. Subsequently, the IIR will work with the IIRA to explore Alumni support for securing internships and institutional partnerships. We will also work with the UWI Alumni Affairs Unit to link the IIR Alumni page and populate UWI Connect with relevant information.

Student numbers at the IIR declined by almost 11 percent, from 84 to 75 during the past academic year. Contributing factors other than the removal of GATE include lapsed registrations and lower new enrolments due to the attrition caused by social and economic difficulties. These sobering results underscore the absolute imperative of investing more heavily in marketing campaigns, strengthening the support for our current students struggling to complete their programmes under more austere circumstances, and continuing to innovate and transform the IIR's programme offerings in order to increase competitiveness and tap into new markets.

One encouraging detail is the increased regional and international enrolment which has been facilitated by remote access to the M.Sc. and Postgraduate Diploma programmes. This is clearly evidenced in the 2021/2022 statistics where regional and international student registration ranged from 10 to 14 percent. This fact must also inform policy-making on future programmes, their delivery modes and target markets.

Student Throughput

In 2021/2022, six PG Diplomas in International Relations were awarded. Two of the graduates received the grade of Distinction in their awards. Fifteen M.Sc. Global Studies degrees were awarded, nine with Distinction. Four PhD awards have been made in 2021/2022. The IIR heartily

congratulates Dr. Lynelle Clarke, Dr. Lisa Gordon, Dr. Kobina Wilson, Dr. Anthony Gafoor, and all other graduating students. We wish them all the very best in the future and we hope for continued engagement with them as valued members of our alumni network.

PROGRAMMES

The Diplomatic Academy of the Caribbean

The annual report on the operations of the Diplomatic Academy of the Caribbean (DAOC) can be found in **Appendix II**. Suffice it to point out that the DAOC has met the objectives and exceeded the targets on participant numbers and revenue set in its Business Plan 2021/2022. The DAOC delivered five online training modules spanning the period August 1, 2022 to July 31, 2023,

These include: Energy Diplomacy: Foreign and Security Policy Contexts in the Caribbean; three iterations of Protocol and Diplomacy: A Guide for the Modern Professional and Advances in Consular Affairs in the Modern Diplomatic Mission: A Caribbean Perspective.

UWI STA Model UN Club

Dr. Georgina Chami continued her work as Faculty Advisor for the UWI STA Model UN Club in 2022/2023. The Model UN Club was able to transition from remote operations to face-to-face while maintaining protocols of sanitization, personal well-being, and public safety. Due to membership demands, meetings were held on a weekly basis (as opposed to bi-weekly done previously). There was further engagement with the membership through round table discussions of current events at the beginning of every meeting: local and international. The goal remains to be improving the club's visibility in the UWI community and to host informative and stimulating activities, establish internal and external collaborations, and engage in community work. The central activities this academic year focussed on aspects of a MUN conference and included writing position papers, clauses, sensitizing on the United Nations' Sustainable Development Goals (SDGs) such as trade and the economy, global security, geophysical and environmental issues.

Semester 1

General club meetings

There were 6 meetings of which the objective was to engage with members and execute the planned sessions. The meetings were meant to be informative and academic as well as entertaining to invigorate friendly competition between members through participation as delegates and as competitors in club game events. During this semester, the executive introduced the world of MUN to members as delegates. Countries were assigned to members who had the option of working in pairs or individually. The functioning and structure of the club (Constitution) were explained to students as well as what it means to be a part of the club (what to expect). Clauses, the resolution paper, rules of procedure, and public speaking were also covered.

		From September 1, 2022, an interim arrangement was put in place and remained in place throughout the reporting period. During that time, the focus was on discussions around the Vice – Chancellor's Task Force for the restructuring of the IIR; reinstating the government subvention as an emergency measure and performing basic functions such as delivering the IIR's programmes.
		At the first meeting of the Task force, the option of the merger of the IIR with the FSS was no longer on the table in light of the view that the Institute's

		identity should be maintained. Members agreed that the IIR should be converted to a centre in light of its financial challenges and the limited scope of centres vis -a -vis Institutes. In light of a letter pledging additional funding from the government to the IIR in the amount of 9 million dollars in February 2023 and disbursement of the funds from April 2023, recommendations to reduce the IIR has been implemented. It is anticipated that all the proposals of the revenue generation committee and raising student numbers are promising and should be fully implemented in the near future as they will contribute to the economic viability of the IIR and the UWI STA Campus
AC1, AC2, AC3	Expanding, updating and customising diplomatic training	It is important to note that the Diplomatic Academy of the Caribbean has a full agenda of its usual professional training modules for AY 2022/2023 and some additional customized training modules that have been prepared in contractual arrangements with private sector clients, as well as its online panel discussions scheduled for Semesters One and Two. The DAOC's schedule of offerings have been prepared as part of its Three-Year Business Plan, Year Three of which was approved by the IIR Board meeting in June 2022. Its first event for AY 2022/2023, actually a delayed module from AY 2021/2022 on The Diplomacy of Energy Security, was delivered from August 2 – 5 2022. Preliminary discussions and preparation are underway for an orientation course for incoming diplomats to Trinidad and Tobago.

Appendix II: The Diplomatic Academy of the Caribbean

Report on the DAOC August 1, 2022 to July 31, 2023

- 1. The Board of the IIR approved (at its 2022 meeting) the Diplomatic Academy of the Caribbean (DAOC) Business Plan for July 2022 to June 2023 which, *inter alia*, makes provision for the delivery of six (6) training modules (in virtual format), as enumerated in the DAOC's *Academic Curriculum AY* 2022/2023.
- 2. The DAOC delivered five (5) online training modules spanning the period August 1, 2022 to July 31, 2023, as outlined in Table 1 (below). For details on the respective modules, click on relevant hyperlinks.
- 3. The scheduled delivery of AY 2022/2023 training modules, up to and including April 2023, experienced some delay. The DAOC Manager took up his allotted study leave from January 9, 2023 to April 13, 2023. In addition, the DAOC has experienced staffing-related capacity constraints. A full-time clerical/administrative assistant is no longer assigned to the Academy's secretariat, which previously has drawn on IIR administrative staff on an *ad hoc* basis.
- 4. Furthermore, given the considerable cost savings relative to in-person/face-to-face offerings and the fact that the virtual format lends itself especially well to attracting participants from outside Trinidad and Tobago, during AY 2023/2024, it is also recommended that DAOC module offerings—in their entirety—ought to continue online (via Zoom).
- 5. While the 'COVID moment' hastened and compelled the DAOC's transition from a fully face-to-face to an online professional development diplomatic training centre, this pivot ought not to limit the scope for hybrid pedagogic approaches going forward. In this regard, in the context of the delivery of one (1) anticipated, participant-paid workshop an innovative face-to-face and online blended pedagogy could be leveraged.
- 6. On the matter of further driving stakeholder engagement and shaping an impactful institutional profile and enterprise narrative, the Manager gave effect to various strategies including maintaining an active publication schedule. This was in recognition of the significance of the pressing international affairs issues of the moment. The circumstances presented an opportunity for the DAOC to take the initiative and exercise thought leadership through the production and wide circulation of relevant research and analysis.
- 7. This series of analyses, spanning the period September 2022 to May 2023, as outlined here (additional works in that regard are available by clicking here), showcase associated CARICOM foreign and security policy approaches—all for the benefit of practitioners,

academics and the wider public. In enhancing public debate and engagement accordingly, such advocacy-related work enabled the DAOC to amplify its impact across an array of partnerships, reinforcing marketing efforts around its core professional development-oriented teaching function.
