OVERVIEW OF THE INSTITUTE

The Institute of International Relations at The University of the West Indies is a regional, autonomous academic institution at the St. Augustine Campus, with associate fellows at the Mona and Cave Hill Campuses, and within other organizations. Since its founding in 1966, the Institute has been dedicated to the conduct of advanced research and teaching concerning the international challenges of the contemporary world, with special emphasis upon the Caribbean and Latin American regions. As a vital part of the infrastructure for its teaching and research, the Institute has developed a Library that constitutes one of the best information resources available, regarding the international relations of the Caribbean. In addition to its Postgraduate Diploma, M.Sc. and MPhil/PhD programmes, the Institute of International Relations, through the Diplomatic Academy of the Caribbean, meets related regional and national human resource development needs by offering short intensive modular training programs for public and private sector and civil society personnel. The Institute also offers international policy research and advisory services and consultancies.

MISSION OF THE INSTITUTE

The mission of the Institute of International Relations is to enhance understanding of Caribbean international relations, applying multidisciplinary perspectives, while contributing to related regional and national human resource development. The Institute of International Relations offers excellent research, teaching and consultative assistance to all stakeholders. The Institute organizes, sponsors or co-sponsors workshops, conferences and seminars relevant to the international challenges of the region, and publishes the online *Caribbean Journal of International Relations and Diplomacy* on a quarterly basis.

VISION OF THE INSTITUTE

The Institute of International Relations brings the expertise and energies of all the international relations academic staff within The University of the West Indies, as well as those of selected Associate Fellows located elsewhere, to bear effectively upon the needs of the Caribbean region's public and private sectors for research, teaching, consultancy and training, concerning the region's international challenges and opportunities, within multidisciplinary fields ranging from finance, business and management to politics, history, economics, education, and law.

GOVERNANCE OF THE INSTITUTE

The governance of the Institute, is vested in the Board of the Institute, which is chaired by The UWI Vice Chancellor. The management of the Institute rests with the Director, who is responsible to the Board for the proper discharge of its functions.

1. DIRECTOR'S - SUMMARY

The 2017 – 2018 academic year for the UWI Institute of International Relations has been marked by a smaller-than-usual number of full-time academic staff and by careful stewardship of our resources. However, it has also featured an impressive number of PhD completions in our M.Phil/PhD programme and scholarly publications emanating from staff members. The management has continued the institutional focus on succession planning, recruitment of new academic and administrative staff, curriculum overhaul and innovation, consolidation of the Diplomatic Academy and expansion of our regional and international outreach. The IIR is emphasizing its efforts towards greater sustainability and resilience in line with the UWI 2017 – 2022 Strategic Plan's axes of Access, Alignment and Agility. The rest of the summary elaborates further on these themes.

2. INTRODUCTION

A. STAFFING

In 2017-2018, three members of the academic staff were away on sabbatical or special leave. In addition, at the end of the 2016-2017 year the IIR bade farewell to retiring and post-retirement stalwarts Dr Mark Kirton and Mr Anselm Francis. The postgraduate Diploma, M.Sc. and MPhil/PhD programmes were delivered by five full-time academics and six adjunct lecturers, with some welcome support from academic colleagues across the UWI in providing supervisory support for research projects in the M.Sc. and PhD programmes.

While Drs. Annita Montoute and Michelle Scobie were away on sabbatical leave, Dr Keron Niles joined us on a temporary full time contract as a replacement for Dr Montoute. The International Law teaching that might normally have been provided by Dr. Scobie was delivered by two part-time lecturers, Ms. Roberta Clarke and Miss Crystal Chapman, while Miss Candice Lackansingh supported the IIR in the delivery of the International Trade component of the curriculum. Dr. Indira Rampersad assisted with the delivery of a Diploma course on Latin American Politics and Dr Ana Teresa Romero continued to provide her valuable support to the Diploma programme.

Staff Departures and Arrivals

Regrettably, Dr Khellon Roach, former Manager of the Diplomatic Academy, left us in April 2018. The IIR is deeply appreciative of the sterling service that he has given the DAOC during the year that he spent there. We welcomed Miss Mary Ann Richards as Manager *pro tempore* of the DAOC in May 2018. Mrs Cherrill Farrell, Head of the Norman Girvan Library (NGL) was absent on medical leave at various intervals during the year and the IIR gratefully acknowledges the support and oversight provided by the Alma Jordan Library and the excellent work done by the NGL library assistants during this period.

As we approach the end of the 2017 – 2018 academic year, Ms Roberta Clarke will leave us as Visiting Research Fellow on July 31. She has made a great contribution to the work of the IIR in reviving and restructuring the CCRON, supervising the research of a couple of M.Sc. students, participating in the work of the planning committee for the 13th annual SALISES Conference on Children's Rights, and offering a Specialized Seminar on Human Rights for students in the PG Diploma programme. We thank Roberta for her support to the IIR and wish her all the best as she assumes new responsibilities as the Coordinator of the National Coalition against Domestic Violence. The IIR looks forward to continued collaboration with her.

The IIR welcomed Mr Winston Dookeran in May 2018 as Professor of Practice for a period of two years. Mr Dookeran was instrumental in the establishment of the DAOC. We look forward to the contribution he can make to academic and professional curriculum development and to reinforcing the IIR's international networks, based on his considerable expertise and long career in the multilateral economic agencies and in national policymaking.

The IIR is still engaged in academic staff recruitment processes. We await the outcome of our efforts to recruit two full-time tenure track academics to boost our capacity in International Security and in the International Political Economy of Climate Change and SIDS Development. We hope to conclude these processes in time for the new academic year.

The IIR Secretariat staff was reinforced with the arrivals of Miss Michelle Seeraj and Miss Joanna McCarter in June and September 2017 respectively. The former combines the duties of Director's Secretary and higher degrees Programme Secretary while Miss McCarty handles the reception area, the preparation of the Internet's revamped website and the management of its Facebook page among other duties. Likewise, Miss Marion Bailey joined the ATS staff on a permanent basis as janitor.

This year, the IIR has benefited from the assistance provided by five junior research assistants, recruited in the capacity of OJTs from the GOTT. Miss Simone Phagoo left at the end of Semester One, while Mr Anthony Phillips-Spencer and Miss Marissa Diaz are with the establishment until July 31 and August 30 2018 respectively. We welcomed Miss Megan Mackoon and Miss Astra Francis to the IIR in Semester Two.

Staff Promotions, Activities and Achievements during 2017 - 2018

Drs Montoute and Scobie are to be congratulated for having been promoted across the Bar at Lecturer level during 2017 – 2018. Both have to their credit an impressive array of scholarly journal articles, book chapters and in the case of Dr Montoute two edited books published between 2016 and 2018. In total, IIR staff members have published in 2017 - 2018 four edited book collections, fifteen book chapters, seven peer reviewed articles in scholarly journals, one technical report and eight encyclopaedic entries. Congratulations to all concerned!! Likewise, academic staff has participated in numerous symposia, workshops and conferences in Trinidad and overseas and have made 37 presentations at these events.

Three staff members benefited from research and development fellowship awards during the academic year. Dr Montoute received a an EU-ACP CARPIMS grant to facilitate a one month research trip to the University of the South Pacific in Fiji in October-November 2017. Dr Scobie received a Canada-CARICOM Faculty Leadership Global Affairs fellowship tenable at the University of Ontario Institute of Technology in Semester Two of 2017-2018. Miss Joanna McCarter was also the beneficiary of a Canada-CARICOM Faculty Leadership Programme award and spent one month at the University of Alberta.

Congratulations are also in order for Miss Ekana McAlister, Administrative Assistant who was awarded her MSc degree in Strategic Leadership and Management at the end of 2016-2017.

B. THE NORMAN GIRVAN LIBRARY

Mrs Cherill Farrell, librarian of the Norman Girvan Library, was away on sick leave to facilitate eye surgery during the months of August and October 2017. During her absence, professional oversight of the library as well as the technical reviews of IIR PhD dissertations was carried out by staff of the Alma Jordan Campus Library. The day to day operations of the library were efficiently handled by the team of library assistants.

In addition to its normal services, the library organized four workshops for students starting with Research Proposal Writing and Research Design in September 2017. In November 2017 and February 2018, workshops were offered on the use of End Note x8 and on Chicago Manual of Style referencing. These workshops proved very beneficial to those students who availed themselves of the facilities. The Institute intends to study the feasibility of running such workshops more than once during the academic year.

The Library's website was redesigned by the staff and has a very attractive appearance in keeping with its function as a major communications tool between the IIR library and its users. During the past year, the NGL organized various educational expositions to highlight the International Day of Tolerance, Disaster Reduction, International Womens' Day and the Nelson Mandela Centenary. Likewise, it joined in the activities to commemorate the fiftieth anniversary of the establishment of diplomatic relations between the governments of Spain and Trinidad and Tobago in November 2017 and was the beneficiary of a generous presentation of books by the Embassy of Spain. The Norman Girvan Library has also been pleased to extend support services to the Library of the Ministry of Foreign and CARICOM Affairs when asked to do so.

The NGL main social outreach project for 2017 – 2018, conducted under the aegis of the Nelson Mandela Centenary, has been the organization of a fund-raising drive to support the Adopt-A-Student fund at the UWI. This continues until July 18 2018 and proceeds will then be turned over to the UWI St Augustine Department of Student Services. Finally, in line with the general trend of reducing expenditure, the library undertook a review of its journal subscriptions, removing twenty-three titles from the list.

ADMINISTRATIVE, TECHNICAL & SUPPORT STAFF TRAINING AND DEVELOPMENT

Diplomatic Academy of the Caribbean (DAOC)

The Diplomatic Academy's year got off to a flying start with the launch of its new website in September 2017. Dr Roach and his team are to be commended for the exceptional quality and presentation of the website and also of the quarterly newsletters that they circulate internationally with updates on the activities and forthcoming programmes of the DAOC. Unfortunately, the Academy's momentum was slowed somewhat by the physical departure of Manager Dr Khellon Roach in December 2017 although he continued to support the DAOC's activities from Canada until the end of April 2018. He was replaced by Miss Mary Ann Richards in May 2018 and we are extremely grateful to Miss Richards for responding with great good will and at short notice to take up this responsibility. Miss Zara Weekes-Rhyzer, Project Assistant has provided admirable support throughout the year. Other research and administrative assistance has been provided by two OJTs and by an intern MPhil student at various times during the year.

C. STUDENTS

The IIR records with deep sadness the untimely death of one of its M.Sc. students, Mr T'Vaughn Lewis in October 2017. His family continues to be in our thoughts.

Lower registration may be partly attributable to the reduced level of tuition subsidy available for graduate programmes from 50% to 25% which came into effect at the start of the current academic year, and to the general downturn in the economic climate. In addition, the IIR has observed a more pronounced tendency towards PT rather than FT registration in its programmes, a trend that has a discernible impact on tuition fee revenue.

With regard to the M.Phil/PhD programme, the IIR chose to delay the intake of some applicants pending the recruitment of new staff with relevant areas of expertise. We have concentrated our resources during the past year on reinforcing the support given to those M.Phil/PhD candidates currently in the system and facilitating their completion. In this regard, five candidates have successfully defended their PhD dissertations between August 2017 and June 2018 while two others have submitted their theses for examination. Three awards of the PhD degree were made in 2016-2017 and three more awards have been made in the current academic year.

The IIR's strategic response to the falling registration figures lies primarily in the initiatives to overhaul and introduce innovations into the curricula and delivery modes of the taught programmes, to increase the marketing of those programmes, and to continue the thrust towards strengthening our academic staffing in certain areas that are important for teaching and doctoral supervision as well as our research output and policy advising capabilities.

Staff/Student Liaison Committee and Student Development, Academic Enhancement Programmes

The Staff/Student Liaison Committee continues to be a useful mechanism for dialogue across the IIR community, for getting feedback about student concerns and their proposals for further improvements to their programme and overall experience at the IIR. The six members of the committee comprise library, administrative and teaching staff representatives, FT and PT representatives of all the degree programmes. This year Dr Keron Niles was the lead academic staff member on the committee. While there were smaller meetings held specific to various programmes and issues, the main meeting took place in February 2018.

Matters discussed included internship opportunities, security challenges and constraints, student amenities, the library and the curriculum, codes of conduct for the classroom. All matters raised in these meetings are being addressed by the IIR. In 2017-2018, the Institute prioritized strengthening its security mechanisms and procedures, improving student access to facilities on weekends, organizing postgraduate forums, seminars and field trips.

In addition to the training workshops provided for students by the Library, the Institute organized a one-day academic writing workshop early in Semester Two for the MSc and PG Diploma students. This was facilitated by Mrs Claudette Jessop of the Faculty of Humanities. The IIR also continued the practice of facilitating the attendance of a certain number of graduate students in the DAOC workshops as a form of professional development.

In 2017 – 2018, the IIR drawing on its Student Development Fund, together with the generous support of the Office of Graduate Studies and Research has facilitated the attendance of three PhD students at local and overseas conferences, workshops and field research trips. Approximately six M.Sc and PG Dip. students have also received support for overseas travel and participation in academic development activities.

Notable among these activities was the Harvard National Model United Nations Event 2018, held at Harvard University, Boston February 15 – 18. HNMUN is a simulation of the UNGA which brings together 3000 students and faculty members from colleges and universities

around the world annually and which enables participants to address and experience the challenges associated with international negotiations and diplomacy. Four IIR students participated as part of a One UWI delegation of twenty students from the Cave Hill, St. Augustine and Mona Campuses. The IIR students were assisted in their preparation by Dr Georgina Chami, Faculty Advisor who accompanied them to Boston, together with colleagues from Mona and Cave Hill. The IIR students found their participation in the 64th HNMUN to be extremely enriching in terms of the personal development impact, the camaraderie and regional unity they experienced.

The IIR students are working towards the establishment of a UN Club at the St. Augustine Campus in 2018-2019 that will enrich the extra-curricular programme of many more students. Dr Georgina Chami, Faculty Advisor for MUN activities is to be highly commended for her leadership and personal commitment of time, investment and financial resources to the Model UN activities at the IIR and on the campus more generally. The IIR and the HNMUN team express deep appreciation also for the support provided by the Office of the Vice Chancellor and the OGSR that allowed them to travel to Boston.

Under the direction of Dr Chami, the IIR continued its efforts to develop partnerships with external stakeholders and identify suitable internship opportunities for its students. The internship programme is envisaged as an annual Summer programme (June – August) although some internships may take place outside of this timeframe. Most internships are tenable in Trinidad and Tobago and most are unpaid. Discussion are ongoing with public and private sector actors as the IIR seeks to expand further the internship opportunities.

Since January 2017, thanks to the determined and well organized efforts of Dr Chami and the generous responses from our external partners, the IIR has received fourteen internship offers: six placements at foreign embassies in Trinidad and Tobago; five positions at regional and international organizations based in Trinidad and Tobago; three positions at a humanitarian NGO in Trinidad. Additionally, the IIR provided one internship from September to December 2017 at the DAOC for a M.Phil/PhD candidate. The feedback from the interns and from their supervisors has been positive thus far and the IIR continues to emphasize to all its students the importance of participating in the internship programme, especially for those with limited previous professional experience.

Due to funding constraints for both the Institute and its students, the IIR has not organized an overseas study trip this academic year. It has sought instead to do field excursions within the country to relevant institutions. In April 2018, students paid visits to the Association of Caribbean States and to the Caribbean Court of Justice. Approximately 13 students took part in each trip. They were warmly received by their hosts with very interesting programmes and generous hospitality. The visits received high approval ratings from the students and the IIR records its profound appreciation to the CCJ and the ACS for their gracious accommodation of our requests. These visits were coordinated by Dr. Jacqueline Laguardia Martinez.

In 2017-2018, through the Erasmus + Caribbean programme that stimulates staff and student mobility across selected Caribbean universities, the IIR accommodated one PhD

student from Universite Antilles, Florence Louis-Edouard, who worked under the supervision of Dr Laguardia Martinez for a semester. Likewise a PhD student from the IIR, Lisa Gordon, did fieldwork for one semester in Guadeloupe on a similar ERASMUS + grant which is facilitating her research on live music industry transactions across the Caribbean. Such mobility exchanges will continue into 2018-2019 when the IIR looks forward to receiving more research student and staff visits from the UA. Finally, in an unrelated scholarly exchange, the IIR is currently accommodating a PhD candidate from Wilfrid Laurier University in Canada while he conducts his fieldwork in Trinidad. Professor Byron is a member of his Advisory Committee.

Diplomatic Academy of the Caribbean (DAOC)

During September 6 – 7 2017, Dr Roach attended the International Forum on Diplomatic Training, held in Santiago de Chile, which focused particularly on training to support the implementation of the SDG 2030 Agenda. Dr Roach was the only representative to attend from the English-speaking Caribbean and the conference represented a valuable opportunity to build the international collaborative networks of the DAOC.

A major highlight of the DAOC's year was its partnership with the Embassy of Spain to commemorate the fiftieth anniversary of the establishment of diplomatic relations between the Kingdom of Spain and the Republic of Trinidad and Tobago on November 9 2017. The celebrations featured a distinguished lecture delivered by H.E. Ambassador Javier Carbajosa Sanchez, an exhibition of the historical ties between the two countries, a symbolic planting of a Chaconia tree in the UWI grounds close to the IIR and a reception offered by the Embassy of Spain. The events were a resounding success.

Between November 2017 and March 2018 the DAOC staged three training modules in Protocol, Diplomacy and Business Etiquette. It is due to offer another training module in the final week of June in Corporate and Diplomatic Communication. It is encouraging to note that one of these modules was organized at the request of the Caribbean Union Conference of the Seventh Day Adventist Church to train the staff of their various churches in the Southern Caribbean and the Guianas and took place at their regional headquarters in Port of Spain. Another noteworthy detail is that in all the modules the registration included participants from other Caribbean territories and from regional organizations including CARICOM, the Eastern Caribbean Central Bank, and various youth organizations. The DAOC also signed a MOU with the Eastern Caribbean-South East Asia Economic and Cultural Chamber and collaborated with the Chamber on March 14 2018 on the livestreaming of a webinar entitled "Introduction to South East Asia: A Cultural Overview on Indonesia".

Unfortunately, the DAOC was obliged to postpone two Protocol and Diplomacy modules scheduled for June 2018 due to low registration figures. During the course of the year it has also had to postpone training modules that were planned in two other Caribbean territories due in one case to the devastation caused by Hurricane Irma, and in the other case to

administrative schedules. The DAOC continues to work on the development of new training modules to be rolled out in 2018 – 2019 and, in collaboration with its partners, to prepare its schedule for the next academic year.

The DAOC and the IIR work in collaboration to organize annually a series of Diplomatic Dialogues which are short guest lectures and discussions delivered by members of the diplomatic community, representatives of international agencies and visiting scholars. In 2017-2018, there were five such events:-

PUBLIC OUTREACH EVENTS AND ACADEMIC/POLICY WORKSHOPS ORGANIZED AT THE IIR 2017/2018

The IIR organized a major public event on September 12 2017, a forum entitled "Regional Perspectives on the Venezuelan Crisis" that consisted of two panel discussions and question and answer sessions livestreamed throughout the UWI territories. The sessions were moderated by Professors Jessica Byron of the IIR and Patrick Watson of the SALISES. The eight panellists were drawn from across the Caribbean and Latin American region and included state and regional/international organization representatives, media personnel, academic analysts and civil society. The forum elicited considerable press coverage and

positive feedback from across the Caribbean from viewers and participants who felt it had contributed new insights and aroused greater public awareness of the issues surrounding developments in Venezuela.

Although livestreaming of this nature is undoubtedly the most effective way for the IIR to reach large segments of the regional and international public, it is costly and the IIR's inhouse budget can only stretch to one or two such sessions annually. However, our IT staff continue to do their own recordings of most public lectures and symposia which are then uploaded to IIR-TV and consulted at will by visitors to the site.

During October 2 -3 2017, the IIR in collaboration with the SIDS Programme in the Woodrow Wilson Centre for Scholars and the Latin American Centre of the American University hosted a scholarly workshop on "The Role of Religion in Responding to Climate Change: Comparative Perspectives from the Caribbean and the Pacific". There were 20 participants from various Caribbean and Pacific territories, North America and Europe. The event was accompanied by a public forum on October 2 entitled "How is Climate Change affecting Small Islands and what can we do about it?" The panellists included Professor John Agard, climate change scientist and Head of the ORDKT of the UWI, Mr Roger-Mark De Souza Programme Director at the Woodrow Wilson Centre, Mr Ronald Jackson, Executive Director of CDEMA, Brother Harrypersad Maharaj of the Trinidad and Tobago InterFaith Organization and Dr. Elizabeth McLeod of climate scientist of the Nature Conservancy Organization. This event can be accessed on the IIR-TV website.

On November 15 2017, the IIR hosted another workshop on "Creative Industries in the Caribbean and their potential for regional diversification and development" coordinated by Dr Jacqueline Laguardia as part of her own research portfolio. The event was done in collaboration with the Norman Girvan Caribbean Studies Centre of the University of Havana and featured excellent presentations from colleagues at ECLAC and the UTT, the UWI, our Cuban colleagues, and creative industry practitioners in the Caribbean. It has spearheaded ongoing research collaboration and conference presentations, including some at the $43^{\rm rd}$ annual CSA conference in Havana in June 2018

Finally, on April 19 2018 the IIR working in collaboration with the Embassy of Chile organized a closed academic workshop entitled "The Second Ministerial Meeting of the China-CELAC Forum: Implications for China-Caribbean Relations and Caribbean engagement with CELAC". This workshop also made full use of distance technology. Participants were present virtually from UWI Cave Hill and Mona and from the China Centre, University of Alberta (notably in the persons of PVC Richard Bernal and Professor Gordon Houlden), there was participation from the Chilean Embassy and from the University of Havana, in addition to representatives from the T&T Ministry of Trade and UWI STA colleagues. It is hoped that this event, like the Creative Industries workshop will stimulate the development of a new research cluster around China's engagement with Caribbean and Latin American partners.

Finally, in terms of increasing public outreach and visibility, the IIR is delighted to announce that all four websites – the IIR website, the NGL website, the DAOC website and that of

CCRON – have been revamped and updated during the current academic year. We commend the hard work and creative energy applied to these projects by the DAOC, Library, Secretariat and IT staff members as well as Ms Roberta Clarke with CCRON.

IIR RESEARCH PROJECTS AND COLLABORATIONS

Caribbean Child Rights Observatory Network

CCRON made considerable progress in 2016-2017 towards strengthening its membership structure and governance framework. It also upgraded its website. During 2017-2018, the most significant activity has been the IIR-CCRON contribution to the organization of the 13th Annual Caribbean Child Rights Research Conference in partnership with SALISES (the lead entity), the IGDS and several other participating agencies. The conference will be held at the UWI Inn, the IIR and SALISES November 15 – 16 2018, on the theme "Leaving No Child Behind: the UN 2030 Agenda". This is the first time the SALISES Child Rights Research Conference will be held at St. Augustine and it has been designated as one of the signature events for the UWI's 70th anniversary.

EU-LAC Focus Project

Professor Jessica Byron continues to coordinate the UWI input into the Social Policy dimension of this project and various components of the research deliverables for the Caribbean were carried out in 2017-2018 by researchers from the IIR and from SALISES Mona, working in collaboration with teams from the University of Chile and research institutes in Austria and Italy. The final report on the Social Dimension of the EU-LAC Inter-Regional Cooperation was expected for January 2019 but since then the project has been extended and has taken a new dimension.

EU-LAC Foundation Project on CARICOM and CELAC

This project was coordinated by Dr Annita Montoute and contributed to by Professor Andy Knight, Drs Debbie Mohammed, Dave Seerattan, Jacqueline Laguardia and . It was successfully concluded in 2017-2018 and the final publication *The Caribbean in the EU-CELAC Partnership* has been published digitally at https://eulacfoundation.org/en/system/files/caribbean study-en.pdf

UWI Research and Publications Fund Research Grant on Cuba-US-CARICOM Relations

This project has been concluded with the production of a book in draft form *US-Cuba Re-Engagement – Implications for CARICOM Countries* which is under review by publishers.

WTO Regional Trade Policy Course Programme

In October 2017 the IIR and the DAOC submitted a bid to the World Trade Organization to host the next cycle of Regional Trade Policy Courses in the Caribbean, which will begin in 2019. In May 14 - 15 2018 a team from the WTO paid a site visit to the IIR. We have received

a communication that the IIR/DAOC has won the bid and the 2019 WTO RTPC is scheduled to take place at the IIR/DAOC from June 1st to July 31st 2019.

Caribbean Journal of International Relations and Diplomacy

The Caribbean Journal of International Relations and Diplomacy has now been transformed into a digital journal. The IIR is currently in the process of updating its editorial and advisory committees. The first digital issue appeared in March 2018. This was a special issue to commemorate the 70th anniversary of the Organization of American States, guest edited by Jeanelle Van Glaanen-Weygel, Director of the OAS Office in Jamaica (and IIR alumna) and Jacinth Henry-Martin, Chief of Staff to the OAS Secretary-General. This was a very successful collaboration which produced a journal issue featuring academics and practitioners from the Greater Caribbean on various dimensions of the work of the OAS, its contributions to regional development, its future challenges and opportunities. The publication was launched at a ceremony at the UWI Regional Headquarters in Kingston on March 5 2018. The programme included remarks by the Jamaican Foreign Minister, an address by OAS Assistant Secretary-General Ambassador Nestor Mendez and a panel discussion by two contributors to the issue, former Jamaican Prime Minister Bruce Golding and Dr Lisa Vasciannie which was moderated by the Director of the IIR.

Two more issues of the CJIRD are currently in the pipeline.

- Increase on a sustainable basis the programme activity of the Diplomatic Academy: **Progress 25%**
- Boost the IIR's research output by UWI and international collaborations and partnerships, and by organizing our own researchers into clusters that correspond to key global and regional development priorities, to the research strengths of the IIR staff and research students and to available research funding: **Progress 40%**
- Build the income-generating capacity of both the IIR and its diplomatic academy affiliate: a long work-in-progress.

This assessment forms the basic content of the IIR's operational plan which is being worked on at present and which will be forwarded to the Board in the next few months

GUEST LECTURERS AND DISTINGUISHED VISITORS 2017-2018

The IIR and the DAOC hosted a number of distinguished visitors during the academic year. The full list is attached in the appendices. Notable examples include the new French Ambassador, the Ambassador of Peru, the Bahamian High Commissioner to CARICOM, the Ambassador of Spain, the Secretary-General of the ACS, the Head of the Office of Public Affairs of the US Embassy, the Political Affairs Secretary of the British High Commission and a delegation from the World Trade Organization.

The IIR draws considerably on its networks in the international community and the national public and private sectors and civil society for added value and practitioner insights that enhance curriculum content. Several guest lectures were delivered in various courses at the IIR during 2017-2018 by an array of distinguished speakers and the list can be found in the appendices. We are very grateful to all the individuals who contributed their time and their professional expertise to this engagement with the students and staff of the IIR. They include diplomat staff from the Mexican, Colombian and Spanish embassies, officials of the IMF, the CARICOM OTN, the IDB, Professor Paulo Correia of the University of Amapa in Brazil, academics of UWI and of the University of Havana, retired diplomats of Trinidad and Tobago.

APPENDIX III: The Norman Girvan Library Interim Annual Report

SUMMARY

Two issues stood out during this academic year which both served to have an impact on service delivery at the Norman Girvan Library: the need for oversight of the Library and assistance with thesis checking during the leave of the Librarian for eye surgery during Semester I, and the Town Hall meeting held by the Principal at the beginning of Semester II. Ms Joy Smith and Dr Shamin Renwick of the Alma Jordan Library both provided oversight of the Norman Girvan Library during the absence of the Librarian on sick leave for eye surgery during the months of August and October 2017. Following on the Town Hall Meeting held by the Principal to highlight the financial constraints and economic challenges facing the University, the Library revisited its budgetary allocation and began engaging in a deselection of journals exercise as part of its overall reduction in expenditure. The Library also undertook another Mandela Day initiative this year by commemorating the 100th anniversary of Mandela's birth with a dollar a day 100 to 100 donation drive. This initiative has been rolled out to the campus community with the proceeds from this drive going toward the Adopt-a-Student Fund which is supported by the Division of Student Support and Development (DSSD). In October 2017, the efforts of the Library Staff were acknowledged and commended when the Librarian received Thank You correspondence from a Law student of the University, a letter which spoke to the culture of quality service meted out 'as a staple' at the Norman Girvan Library.

ACTIVITIES FOR THE PERIOD IN REVIEW 2017/2018

At the beginning of the academic year, in September 2017, "Library Labs" were introduced as part of the Orientation programme. This took the form of two sessions, one on Proposal Writing and the other on Research Design, representing a collaborative effort with a former Faculty member. The two modules of instruction comprised: - 'A Working Title for your Proposal' and 'Research Design and Methodology'. These sessions were facilitated by former Lecturer Dr Marlon Anatol. Two further training sessions were also arranged for students and staff of the Institute during the academic year: - one on EndNote x8 training on November 14th, 2017 and another on the Chicago Manual of Style Author/Date format (16th edition) on February 1st, 2018.

It being the end of the Institute's fiftieth anniversary celebrations, the banner on display in the Library was dismounted in January 2018 and a call issued to the campus community for the signing of the banner which would now be held as a keepsake for the Library.

In the absence of the IIR Librarian on leave for eye surgery during the months of August and October 2017. Dr Shamin Renwick, Senior Librarian, and Ms Joy Smith, Librarian, of the Alma

Jordan Library, both provided professional oversight of the Norman Girvan Librarian. Dr Shamin Renwick and Mariella Pilgrim, Faculty Liaison Librarian also assisted with thesis reviews.

With regard to staffing, Miss Yentil Heller, the On-the-Job trainee, resigned with effect from September 11th, 2017. Miss Aisha Harvey was hired as a Student Assistant for Saturday duty for Semesters I and II of the academic year, while Miss Camille Jackman served as Student Assistant during the semester break from July 24th to August 18th, 2017. The outstanding issue of the completed job evaluation form of the Library Assistant II, Grade 5, was raised by the Director with Dr Linda Steele of Human Resources, for consideration and potential upgrade to the position of Library Assistant III, Grade 9.

Work on the redesign of the Library's website was a major undertaking this year. It was initially begun by Ms Carrill Melville and continued by Mrs Premma Ramsawak on her return from maternity leave. Both members of staff were provided with the requisite training and skill set to complete the exercise. The website is targeted to be launched in June 2018, along with the Institute's website. A YouTube page has also been created. The Library enjoys high visibility among the students with its Facebook page.

The displays featured this year included What to Do with a Degree in International Relations, Resources on Research Proposal and Thesis Writing, International Day of Tolerance, International Day for Disaster Reduction, International Women's Day, Information Resources on courses offered for Semester II and The Nelson Mandela Centenary 2018, 100 days countdown to July 18, 2018.

The Norman Girvan Library continued with its outreach activities, on this occasion to the campus community with a campus wide fund raising drive in support of the Division of Student Services and Development 'Adopt-A-Student Fund.' With the Mandela Day Foundation marking this year 2018 as the centenary of Nelson Mandela's birth, and the Foundation promoting a one hundred (100) day countdown to his birth date on July 18, #100 to 100, the Library sought the campus community's participation in a dollar a day donation drive, with persons having the opportunity to contribute one dollar a day for every day of the 100 day countdown. The Library chose this initiative in an effort to raise even greater awareness of the Adopt-A-Student Fund to the campus community and to significantly boost its contributions. Both Ms Carrill Melville, the brainchild of this project, and the Librarian attended a reception hosted by the High Commissioner of South Africa in celebration of South Africa's Freedom Day in April 2018, and apprised the High Commissioner of the Library's initiative in support of Mandela Day 2018.

The Embassy of Spain in Trinidad and Tobago, and the Diplomatic Academy of the Caribbean at the Institute hosted an Evening of Celebration in November 2017, in recognition of 50 years of diplomatic relations between Trinidad and Tobago and Spain. On this occasion, the Embassy presented the Library with a gift of documents in Spanish for addition to the Library's collection.

Termites were observed in a wooden partition in a select area of the Library and brought to the attention of the relevant authority. A quotation was sought from Rentokil Initial and funding approval was granted to proceed with the fumigation of the Norman Girvan Library during the semester break, May to June, 2018.

An upgrade was sought to the Tab 16 configuration of Aleph 500 to allow borrowing privileges to members of the retired academic staff, facilitating the borrowing of two items on 7 day loan by this patron status. This request was facilitated by the Alma Jordan Library and took effect on April 30^{th} , 2018.

With the financial situation facing the University, and the adverse effects on expenditure, the Library proceeded to undertake a journal deselection exercise, with some twenty three titles being deselected over the last two years when the initial cuts took effect. Consultation was sought with the academic staff for their input into this exercise.

Three theses were reviewed during the course of this academic year.

- Implementation and rollout of the New Thesis Guide, 2015 to IIR Students and Staff
- Upgrade to Aleph 500- change to circulations, effecting loan of two items to Academic Retired staff
- Removal and signing of the Library's fiftieth anniversary banner (as a mark to the end of the 50th anniversary celebrations)
- Conduct of Patron Satisfaction survey of the Monographic collection
- Continuation of Information Literacy Sessions to Academic Staff/Students
- Library Representative serving on the IIR Staff-Student Liaison Committee
- Continuous updating of the skills of Staff through training and development, to enhance quality service delivery.
- Continued employment of Student Assistants on Saturday duty during Semesters and to work on special projects during the Semester break of June to August.
- Interactive engagement of the staff/student body through the continued hosting of a 'What's
- board' and a 'How are you feeling today' board'.
- Receipt of acknowledgment of the exemplary service meted out by members of the Library Staff

Facilities Upgrades

- Annual polishing of the Library's floors
- Further upgrade to the air-conditioning units
- Replacement of the photocopier and copy card unit for the Library
- Impending fumigation of the Library for termite treatment, May to June 2018

Given the current financial climate with continuous cuts in funding, the Library was apprised of a reduction in estimates to the sum of \$612,127 for the academic year 2017 to 2018.

Following on the drafting of the St. Augustine Campus Libraries Operational Plan 2017 – 2019, the NGL Librarian attended a professional staff meeting in the AJL which was called in March 2018 to highlight the relevant action items and the progress achieved to date in these areas. With reference to the strategic direction of Innovation and Entrepreneurship, the Library Assistant III, Grade 9 attended a workshop on 'Patents and Patent Mining' which was held by the Alma Jordan Library in collaboration with The Office of Research Development and Knowledge Transfer and the Intellectual Property Office of the Ministry of the Attorney General and Legal Affairs. This Workshop was held on February 28th, 2018.

The Library did not have an input in this year's Accreditation exercise at the University.

OUTREACH ACTIVITIES

As part of its engagement process, the Library continued to extend its outreach activities to campus and community stakeholders as follows:

- -The extension of support services to the Library at the Ministry of Foreign and CARICOM Affairs
- -Interactive boards engaging the feedback of Staff and students, including undergraduate students in the Faculty of Social Sciences, who make full use of the Library. These two boards include a "What's On' board inviting comments, and a 'How Do you Feel Today' board, also engaging feedback.
- Special initiative in which the section is involved
 - -In commemoration of Nelson Mandela Day, July 18, 2018, which celebrates the centenary of his birth, the Norman Girvan Library is hosting a dollar a day donation

drive as part of the countdown to his birth date. This initiative has been rolled out to the departments on the St. Augustine campus. The proceeds of this drive will be deposited in the Adopt-A-Student Fund which is supported by the Division of Student Support and Development, in an effort to raise greater awareness of the fund to the campus community.
