# Schedule for Phased Resumption of On-site Campus Operations

June 12, 2020

Dear Colleagues,

As we continue to respond to the evolving COVID-19 situation, our focus remains on ensuring the health and well-being of our staff and students, and contributing to the community-wide effort to "flatten the curve" of the pandemic. The Incident Management Team (IMT) has developed a **Resumption of On-site Campus Operations Plan** and I write to provide an update on the rollout of this plan.

The Campus plan involves **a four phased return to on-site operations** commencing **Monday** - **June 15**, **2020**. It uses a risk-based approach and at each stage, risk assessments and action plans are to be submitted and approved by the Campus Management, the Ministry of Health, and the Ministry of Education.

This phased approach is intended to allow for:

- a. Spreading the burden of cleaning, maintenance and retrofitting mitigation measures over a period of time to ensure that these activities are effectively carried out with the existing resources
- b. The effective review and approval of departmental action plans and monitoring of implementation

- c. The gradual return of the Campus community and the effective attention to any issues that may arise
- d. Effectively facilitating any rollback to lockdown, should this be mandated by the Government in the event of a second wave of infection

To support the plan and the implementation strategies in all these phases, the Campus will:

- a. Provide sensitization training for Deans, Directors and Heads of Departments (HOD) in a range of areas
- b. Provide hygiene and COVID-19 health awareness for all members of staff
- c. Provide sensitization training for all cleaning staff on guidelines established by the CDC / Ministry of Health
- d. Provide face covering to employees
- e. Provide handwashing stations installed outside high traffic spaces
- f. Provide additional PPE to employees whose jobs require same
- g. Enhance cleaning and ensure additional cleaning supplies are available through Central Stationery Stores
- h. Provide guidance through the OHSE Unit on how to improve work space design and signage to support social distancing and additional hygiene measures.

All staff will receive guidance from their HOD with respect to the departmental resumption of on-site operations, relative to each phase. Should you have any concerns or suggestions with respect to these departmental plans for the resumption of duty, these should be directed to your immediate supervisor and HOD. HODs are encouraged to liaise with the Division of Human Resources if there is uncertainty or concerns from their staff.

You are reminded of the **public health guidance** set out by the Ministry of Health that calls for physical distancing, regular handwashing, wearing of masks in public, regular cleaning and disinfecting of frequently touched surfaces daily. We ask for your cooperation with these guidelines.

Please note the following specifics of the resumption for each phase outlined below.

#### Phase One

Phase One will commence on **Monday**, **June 15** and involves the continuation of essential work, key administrative functions, and critical research activities. Departments are expected to gradually implement their action plans over a period of two weeks.
