Experts and scholars in the field of public management will be invited to give lectures to the participants, and various teaching methods such as classroom lectures, on-site teaching, cultural experience, visit, exchange and discussion will be used comprehensively. The training mainly covers China's development, China's national governance, China's economic development and reform and opening up, China's public policy formulation, etc.

- 1. China's development (summary of China's national conditions): introduce the general situation of China's politics, economy, history and culture, so as to enable the participants to have a preliminary understanding of China and provide theoretical basis for future study and exchange.
- 2. Xi Jinping's thought of socialism with Chinese characteristics in the new era: introduce the background, ideological connotation, historical status and world significance of Xi Jinping's thought of socialism with Chinese characteristics in the new era. Explain the basic connotation and logical structure of "Ten Clarifications" and "Fourteen Adherence", and the historical achievements and changes of socialism with Chinese characteristics since entering the new era. Interpret the scientific answer of Xi Jinping's socialism with Chinese characteristics in the new era to the question of China, the question of the world, the question of the people and the question of the times.
- 3. Modernization of national governance system and governance capacity: introduce the structure and operation mode of Chinese government; focus on introducing the experience and practice of how the Chinese government under the leadership of the Communist Party of China can promote the modernization of national governance system and governance capacity in reform, development and stability, economic and social construction and diplomacy.
- 4. Co-constructing high-quality development of the "Belt and Road": introduce the historical inheritance and era background of the "Belt and Road" initiative, the basic principles, operating mechanism, achievements and development prospects of the "Belt and Road" initiative. Focus on the cooperation and practical experience of the countries and regions where the participants are located participating in the "Belt and Road" initiative.
- 5. Building a community with a shared future for mankind: introduce the concept and connotation of the community with a shared future for mankind, as well as the basic principles, values and action path of the community with a shared future for mankind. Explain China's experience and practice in building a community with a shared future for mankind, and explore China's role and responsibilities in global governance. Explore how countries in the world can strengthen cooperation to jointly address global challenges and promote the common prosperity and development of mankind.
- 6. China's public policy-making: introduce the characteristics and implications of public policy-making process, influencing factors and principles of public policy-making in China, as well as the main public policies in China under the background of reform.
- 7. Chinese government performance management: briefly introduce the experience of government performance management in China from the aspects of the characteristics of China's political system, leading government performance budget, overall performance management of local government, assessment of leading group and leading cadres, performance management of civil servants and evaluation of social satisfaction.
- 8. China's economic development and reform and opening-up: introduce the process, characteristics and trends of China's economic development since the reform and opening-up. Explain the achievements of China's economic development in the past 40 years of reform and opening up and its impact on the world.
- 9. Civilized exchange and mutual learning: deepen cultural and cultural exchanges and learn from each other through the discussion and exchange of Chinese experts and participants. Chinese experts will introduce the origin, present and future of Chinese civilization. Participant delegates share the origin and characteristics of civilization and cultural exchanges of their countries with foreign countries.

## Lecturer Introduction

- 1. Dong Zhenhua: Director and Doctoral Supervisor of Philosophy Teaching and Research Department of China National Academy of Governance, President of National Applied Philosophy Research Association, Executive Director and Deputy Secretary-General of China Dialectical Materialism Research Association, and experts enjoying special allowance of the State Council. The research interests include Marxist philosophy, philosophy of development, socialism with Chinese characteristics, etc.

Zhao Lei: Vice President and Professor of the Institute of International Strategy of the China National Academy of Governance, member of the "Country and Regional Research Expert Committee" of the Ministry of Education, member of the Central Enterprise Youth Federation, Deputy Secretary-General of the Decision-making Advisory Committee of the National Ethnic Affairs Commission, expert of the "Belt and Road" Economic and Trade Cooperation Expert Group of the Ministry of Commerce. The research interests include international relations, China's diplomacy, multilateral diplomacy and cultural soft power, and international cooperation construction of the "Belt and Road".
- 4. Wang Xuebin: Professor of the Teaching and Research Department of Literature and History of the China National Academy of Governance, Director of the Teaching and Research Section of Chinese History, and Nishan Scholar. Doctor of History, Beijing Normal University, Postdoctoral, Institute of Modern History, Chinese Academy of Social Sciences. Focus on the comparison of Chinese and Western political and cultural history.
- 5. Chen Jianqi: Professor of Institute of International Strategy, China National Academy of Governance, Doctoral Supervisor, Postdoctoral of Economics, Visiting Scholar of Georgetown University, USA. He has published more than 200 papers in "Economic Research Journal", "The Journal of World Economy", "Journal of Financial Research" and other journals, served as an anonymous review expert of "Economic Research Journal" and other journals, and presided over major special projects of the National Social Science Foundation of China and other subjects.
- 6. Ma Xiaofang: Professor of Economics Department of China National Academy of Governance, Doctor of Economics, Graduate Supervisor. Visiting professor of Academy for International Business Officials, Ministry of Commerce. The research interests include government economic management, international finance and international trade, exchange rate theory and system, and the "Belt and Road" construction.

During the seminar, participants will be arranged to learn and experience daily Chinese and Chinese calligraphy culture. In addition, we have arranged participants to study outside Beijing, visit Party and government organs, enterprises and public institutions, and investigate "one-stop" public service, regional economic development and scenic spots showing China's economic and cultural characteristics.
