Notice is hereby given that Final Examinations for Summer Session 2024/2025 will begin on July 14, 2025. The following is important and critical information for your guidance.

EXAMINATION TIMETABLE & FINANCIAL CLEARANCE

Please be advised that Summer Session 2024/2025 Final Examinations will be held in a **Face-to-Face/In-Person Mode** for:

- All other Faculties: July 14-25, 2025
- The Faculty of Medical Sciences: July 14 to August 15, 2025

Your **individual** Final Examination Timetable has been published in the “My Secure Area” within the student portal. You must be **duly registered and financially cleared** to access examinations for your course(s). Use the following link to access the student portal to view your timetable: <https://my.uwi.edu/c/portal/login> or idp.quicklaunchsso.com.

The time on the Final Examination Timetable is posted in Atlantic Standard Time (AST) (GMT-4) (local Trinidad and Tobago time).

Your individual Final Examination Timetable also contains information on your Financial Clearance including the date up to which you have been cleared. You are to confirm that you have financial clearance for the entire examination period. **Candidates are advised to continually check their timetable in the “My Secure Area” for possible updates or changes to registration, dates of the examination or financial clearance.**

If you have not yet received financial clearance, please liaise with **Student Accounts and Receivables, Bursary** to determine your financial status and thus, your eligibility to write final examinations.

Please be reminded that **June 30, 2025**, was the deadline for students registered for the Summer Session to meet their financial obligation to The UWI. This means that any outstanding payments and/or the submission of the relevant documents should have been made via e-Courier on or before that date.

Failure to do so will result in an Accounts Receivable (AR) Hold being placed on your student account. An **AR Hold** negates previously issued financial clearance and restricts access to:

- My eLearning to write or submit online assessments or view posted course content
- The examination venue to write in-person final exams
- Registration for the relevant and future semesters
- The services offered by the Alma Jordan Library
- Obtaining an ID card

STUDENTS ARE ADVISED THAT ENTRY TO EXAMINATION VENUES WILL BE DENIED IF FINANCIAL CLEARANCE CANNOT BE CONFIRMED.

UWI IDENTIFICATION CARD AND EXAM ENTRY

You are advised to arrive at your examination venue **at least 30 minutes** before the start of the examination.

Your valid UWI Identification Card must be presented in order to gain entry into the examination venue.

Invigilators will scan your ID card to verify that:

- ✓ You are **registered** for the course.
- ✓ You are **financially cleared**.
- ✓ You are at the **correct exam venue**.
- ✓ The person presenting the card matches the photo ID.

Candidates shall bring their examination cards (where applicable), and their UWI Student identification cards to each examination. They must display their identification cards and their examination cards (where applicable) in a prominent position on their desks. Candidates shall not normally be allowed to write an examination without a valid UWI Student Identification Card [[Examination Regulations 2020/2021 92\(a\)](#)]
