#### Introduction

The Institute of International Relations (IIR) is a centre institution of The University of the West Indies. Established by Swiss funding in 1966, the IIR has become a well-established and highly regarded interdisciplinary Caribbean regional centre for the analysis and advancement of international relations. It has trained many of the Caribbean's political, business and diplomatic leaders over the years. Located on the St. Augustine Campus of The University of the West Indies, the Institute offers a programme of courses and supervises research leading to the Postgraduate Diploma in International Relations; M.Sc. in Global Studies; M.Phil and Ph.D. in International Relations.

The programme of courses comprehensively covers the geographical, historical, political, economic, social, cultural, legal and institutional aspects of international relations and emphasizes an inter-disciplinary approach in the study of relations between nations and other entities. In addition to conducting teaching, research and study of international relations, the Institute engages in many activities including the organisation of special programmes, courses and seminars, and the provision of consultative assistance and research, for the governments and private sectors of the region, and regional organisations and agencies, which are intended to strengthen Caribbean responses to the challenges of international relations and the understanding thereof in the community at large. The Institute of International Relations is committed to training the next generation of diplomats from the region. To this end, a new diplomatic training centre – The Diplomatic Academy of the Caribbean – was launched on 6 May 2014.

#### **Governance of the Institute**

The governance of the Institute, chaired by the Vice Chancellor, is vested in the Board of the Institute. The management of the Institute rests with the Director, who is responsible to the Board for the proper discharge of his functions.

## A. STAFF

#### **Director**

Professor W. Andy Knight is currently the Director of the IIR. He is the tenth Director of the Institute and assumed duties in January 2013. His goal is to build upon the excellent work done in the Institute over the years, and to use his experience, connections and networks to expand the IIR's reach and make it better known throughout the world. He has re-established connections with bodies such as the ACS, CARICOM, CELAC, and the OAS in the region, with diplomatic and consular corps present throughout the Caribbean and with multilateral institutions such as the United Nations System, the Commonwealth.

#### **Diplomat in Residence**

Dr. Teruyuki Tsuji is currently attached to the Institute of International Relations, The University of the West Indies as a Diplomat-in-Residence (September 2014-August 2015). Previously a member of Japanese diplomatic delegation at Trinidad and Tobago, Dr. Tsuji served Japanese Embassies in Port-of-Spain (1994-1997) and in Kingston (1998-2000) as a research analyst and cultural attaché. He completed his PhD in Comparative Sociology at Florida International University. His dissertation committee was chaired by Alex Stepick, a known scholar of international migration studies, and included Dr. Anthony Maingot, an affiliate of the IIR, and Kelvin Yelvington known for his research on Trinidad and wider Caribbean. He has been working to develop a book manuscript, which focuses on one of the significant ethnographic cases discussed in his dissertation: La Divina Pastora devotion in Siparia. The affiliation to IIR and broader UWI allows him to conduct additional ethnographic and archival research in order to complete the manuscript. His project has been funded by Japan Society for the Promotion of Science.

#### Visiting Fellow

Dr. Simon Hollis, a visiting fellow from October 2014-December 2014, is a Postdoctoral researcher at the Swedish National Defence College<sup>1</sup> and Lecturer in Risk and Disaster

Management at the CORTRA Training and Consultancy in association with the Geneva Graduate School of Governance. Dr. Hollis received his PhD in international relations at the Hertie School of Governance in 2012. His thesis examined the role of regional disaster risk management programmes. A revised version is currently in production with Palgrave Macmillan (*The Role of Regional Organizations in Disaster Risk Management: A Global Strategy for Resilience*). Dr. Hollis has also published in a variety of international peer-reviewed journals on various aspects of international and domestic cooperation on disaster management. He is a postdoctoral researcher at the Swedish National Defence College and lectures on risk and disaster management in association with the Geneva Graduate School of Governance.

As part of his postdoctoral project, funded by the Swedish Civil Contingencies Agency, Simon is examining the role of international organizations in supporting Disaster Risk Reduction (DRR) in small island developing states in the Caribbean and Pacific regions. The main aim undergirding this project is to increase our knowledge on how DRR principles can create more resilient and safer societies for the future.

#### Condolences

Professor Yves Collart, the third and last Swiss Director of the IIR (1969-1973), died on October 29, 2014 at the age of 84. Professor Collart was instrumental in successfully converting the joint venture, established in 1966 between the Governments of Switzerland and Trinidad and Tobago,



into a regional institution fully controlled by Barbados, Guyana, Jamaica and Trinidad and Tobago. A firm believer in local potential, he achieved this conversion at a date much earlier than anticipated. One of his major accomplishments was the incorporation of IIR into The UWI under a constitution that would give IIR a certain degree of autonomy while still subject to The UWI staff, degree and administrative regulations and

standards. IIR is still governed by that constitution. Prof Collart drew commitments from regional Governments to, not just financially support the Institute, but also to send their diplomats for training. He made it a place where both academic and practical diplomatic training could thrive.

His administrative achievements were matched by his academic ones in his specialty, History and International Politics. He gave courses and seminars, supervised graduate students in this area and was well known for his rigorous historical method to the study of International Relations.

After his departure, he continued to serve on the IIR Board, continuously promoting international cooperation between IIR and the Graduate Institute of International Studies in Geneva along with other international bodies. He was well loved by his students who admired his humility and dedication to excellence. Some of them such as Orville London, Colin Granderson and Henry Gill, to name just a few, went on to greater achievements.

The Institute of International Relations mourned the loss of *Dr. Johann 'Hans' Geiser* who served as a temporary lecturer (Part-Time) for the academic year 2014/2015 in the course INRL 5000: Specialised Seminars. Dr. Geiser fell ill in Semester II and the former Lecturer at the Institute of International Relations and one of the pioneers of the Diplomatic Academy of the Caribbean, passed away on May 11, 2015.

In 1972, Dr Geiser was a member of the team that set up the Institute of International

Relations (IIR) at The UWI. He lectured there until 1974 when he left for New York to head up the UNITAR's International Law Training programme for government legal advisers and university professors from various developing regions.

As Chief of the European Office of UNITAR (1976-1981) Dr. Geiser acted as liaison between the UN Specialized Agencies and European-based international organizations. In 1989 Kofi Annan appointed him Director of the Training Department at the International Training Centre of the International Labour Organization in Turin, Italy. Concurrently, he served as the first Director of the United Nations Staff College in Turin.

Nine years later Dr. Geiser would return to the Caribbean as UNDP Resident Representative and UN System Resident Coordinator with responsibilities for Trinidad & Tobago, Suriname, the Netherlands Antilles and Aruba. After that tour of duty, he lectured at the Institute of International Relations on Sustainable Development and Human Rights on and off until semester II (2014-2015) when he delivered his final class to students of the Institute of International Relations at the St Augustine Campus.

- The extension of support and collaboration and with the Library at the Ministry of Foreign Affairs.

# Major accomplishments of the reporting section - IIR Library

Although renovation work was scheduled to begin on July 21st 2014, work actually commenced on Monday August 4th, 2014. Staff regained access to the Library on Tuesday 26th August while the Library reopened for service on Tuesday 2nd September, 2014. The Library was closed again on Friday 5th September to accommodate additional roofing work. The construction of a wall on the western end of the Library elicited concerns by staff over the loss of natural light in that work area and an emergency exit route. In January 2015, there was an electrical fire at one of the student terminals following a power surge with both machines remaining out of service for the remainder of the second semester. Mr. Sagar of the Occupational Health, Safety and Environment Unit paid a visit to the Library on May 1st, 2015 to advise on safety procedures and later on May 7th to conduct the Pregnancy Risk Assessment for Miss Malika Charles. Three of the air conditioning units in the Library were recommended for changing following malfunctioning of the units. One unit was replaced in June 2015.

With reference to staffing, Student Assistant Keshan Latchman continued with Saturday duty while Student Assistants Kwasi London and Jenille Gray were hired to undertake select library projects over the period July 1<sup>st</sup> to August 14<sup>th</sup>, 2015. The newly established position of Library Assistant III, Grade 9 was initially advertised in May 2015. The issues of late shift allowance for the Library Assistants and the payment of the travel allowance along with compensatory time off for Saturday duty were matters which were raised by the Library Staff for clarification during the academic year.

Installation of three Dell smartcard reader keyboards was finalized when the Library reopened for service in September 2014. With regard to working in Aleph, Staff encountered issues with some records not showing up in UWIlinC following the copy cataloguing of these documents: - this was brought to the attention of the relevant staff at the AJL. Work continued on the entry of data into the Serials/Acquisitions module of Aleph with ninety six journal entries to date. Following on a request for refresher training on the setting up of staff profiles and the creation of staff proxies, this training was facilitated by Sham Narine of the AJL in March 2015. The IIR Library Staff, working in close collaboration with the Acquisitions librarian at the AJL, were also able to set up online access to thirteen (13) IIR journal subscriptions to the wider Campus community. In spite of its restricted budget, the IIR Library has gone the route of e-resources and acquired its first e-book in September 2014.

Student papers from the Diploma programme for the years 2003 to 2013, and MSc. Student research papers for 2008 to 2013, were submitted to the Alma Jordan Library in July 2014 for entry into UWISpace. With the entry of these papers in UWISpace, the Library has been receiving requests by researchers for access to these documents. Given the issue of copyright, a letter has now been drafted for remit to the students (authors) seeking permission to grant access. The Library has also received a written request from one IIR Student seeking withdrawal of her Seminar paper from the library's collection of student papers and, in addition, from UWISpace. This measure has led to a call for a review of the collection of student papers which will now take place during the academic year 2015 to 2016. At the beginning of the second semester, students encountered problems with registration which affected loans and circulations. In June 2015, the IIR Library submitted a request for changes to be made to TAB 16 of Aleph with specific reference to due return time for Reserve Overnight loans and 7 Day loan facility for IIR ATS Staff.

At the request of the Permanent Secretary in the Ministry of Foreign Affairs, the IIR Library hosted Gloria Deoraj-Deen for one week of intensive training during the period January 19<sup>th</sup> to 23<sup>rd</sup>, 2015. In February 2015, the Library received a request from the

Director for the extension of borrowing privileges and the use of the Library by five Analysts working as part of a Committee on National Security. Access to the Library's facilities was granted for Semester II of the academic year. During the period March 9<sup>th</sup> to 25<sup>th</sup>, 2015, the Library hosted an Intern from the College of Science, Technology and Applied Arts of Trinidad and Tobago (COSTAATT). The Intern, Ayanna Lopez, was trained in all aspects of the Library's operations. A request was also forthcoming from Wendy Sealy, former Librarian at the Institute, for the training of a Library Assistant from UWI-Roytec, Mr. Justin Piper for one day on April 29<sup>th</sup>, 2015.

Displays during this year featured an array of international themes. In September 2014, the Library showcased its signature "What to do with a Degree in International Relations". The Library was transformed into an "oceanic experience" for World Oceans Day while, with the International Day of Forests on March 31<sup>st</sup>, a "Tree of Information" was mounted from floor to ceiling inviting comments from patrons: these comments were pinned to the tree. Displays were also mounted paying tribute to Professor Yves Collart, the third Director of the Institute who passed away on October 29<sup>th</sup>, 2014, and to commemorate the life of Dr Hans Geiser, former Lecturer at the Institute who died on May 11<sup>th</sup>, 2015. A request for assistance with a display was also forthcoming from one Lecturer, Dr Georgina Chami, seeking the Library's input in the setting up of a CCRON display for a Youth Development conference held on March 23<sup>rd</sup> to 27<sup>th</sup>, 2015.

At a Staff Meeting in January 2015, the Director informed Staff of a decision coming out of the Board meeting in June 2014, to rename the IIR Library "The Norman Girvan Library" in honour of the late Professor Emeritus Norman Girvan. This proposal was sent to the Naming Committee.

#### **Academic Competitions**

The 33<sup>rd</sup> Model OAS General Assembly for Universities of the Hemisphere was held in Saint Kitts & Nevis from March 24 – 26, 2015. It was co-organized by the Office of the Assistant Secretary General of the Organization of American States (OAS) and the Ministry of Youth Empowerment, Sports, Information Technology, Telecommunications and Posts of Saint Kitts and Nevis.

## **Cuba/Panama study trip**

The following article '*The Cuban Paradox: Poverty in Paradise*' is written by Chinaka Nelson about the August 2014 study trip to Cuba and Panama.



It is Sunday 24<sup>th</sup> August 2014 and a small group all clad in navy blue polo shirts, with the visible IIR logo join the obscenely long line at Piarco International Airport. The fatigue etched on everyone's faces betrayed the events of the last week, one dominated by edifying forums and leisure activities that catered to all involved. The experience provided much needed relaxation for staff and students alike, but, like true academics, the trip would have been incomplete had it not raised thought provoking issues and forced us to interrogate popular opinion.

Cuba, (where the group spent most of its time) is both maligned and praised in contemporary discourse. The island is perhaps best known for having produced the controversial figure, Fidel Castro who spearheaded the Cuban Revolution and later ruled the country for decades. Of the rebellion, Castro once said that it "is a struggle to

the death between the future and the past." Our visit to the island underscored just how much the country wavers between navigating a bright future despite a nostalgic attachment to a foregone era.

Sweltering heat welcomed us to Cuba. The formalities at Immigration and Customs were routine except for some provocatively dressed female staff with their black fishnet stockings and short skirts triggered whispers of shock and surprise from members of our group. As the rich aroma of Cuban cigars infiltrated our nostrils and the vintage vehicles came into view, it was certain that this would be no ordinary trip. Our first lesson, courtesy Dr. Laguardia Martínez, was at the airport as we learned of the different exchange rates for foreign currency. The next came as we huddled into taxis en route to the *Hotel Nacional*; air conditioning is a luxury. As we encountered more antique cars, coco taxis and reformatted bicycles that functioned as taxis, it was evident that Cubans are a resolute people. Whether by choice, circumstance or both, they are a creative bunch who have adapted to life on the largest Caribbean island, trivia made apparent by the vast available land that became visible as the plane descended into the José Martí International Airport.

The educational seminars spanned a three day period and the well informed panellists engaged our attention with intense discussions about Cuba's past and the possibilities for a brighter future. The island's political and economic landscapes were central points of the dialogue. With high unemployment and a bloated state bureaucracy, Cuba is economically fragile. Its move from a heavy dependence on sugar exports to a service centered economy is indicative of the country's attempt to insert itself in the global system but has also left hordes of people under or unemployed. Further, with its aging population, a human resource crisis looms. Add debt and little disposable income and the equation becomes even more complicated. Arguably worse than this though is the Cuban dependency syndrome and socialism, a product of the Revolution does not appear to have a solution to this acute problem.

The Cuban Revolution, premised on social justice as a means for development demanded political consensus and social cohesion. Its success cannot be overstated but more than half a century later, its relevance is called into question as the continued absence of democratic governance is an issue with which the country's leaders must contend as efforts are made to engage the global community. Thus, the island's foreign policy can no longer be shaped by domestic size and concerns. Multilevel reform, inclusive of an attitudinal shift by both citizens and the government is necessary. While this stance suggests that socialism is not a tenable model, there are those who believe that Cuba should cling to the gains from the Revolution. They submit that the revolutionary spirit must not be suffocated by modern day woes.

While the lectures furnished us with rich information about Cuba, nothing compares to living the experience. During our tour of Old Havana, there was that surreal feeling that we had entered another time period. The ancient buildings, canons and statues permitted Dr. Laguardia Martínez to share her expert knowledge of Cuba's history. Still, history is never far from reality as young children approached us pleading for a financial donation. The elderly woman too, dressed in full costume demanded that we pay her for snapping a quick photo. Some of us rode a carriage for the first time while others opted for more conventional means of getting around the old city.

La Plaza de la Revolución afforded us the opportunity to walk where national heroes once did. Opposite the plaza, hangs the unmistakable image of Che Guevara, a constant reminder of his indelible role in Cuban independence. Despite the scorching temperature, everyone took pictures, ensuring that this trip would not only be etched in our memories.

At *el Museo de la Revolución*, the curator recounted the life of José Martí, a key figure in Cuba's fight for freedom. The unwavering passion and fervor with which she chronicled his life's adventures was not limited to her; it seemed to be an innate Cuban trait. It was evident on our visit to the Caribbean Association of Residents in Cuba. The warmth and love were almost tangible as members of the small audience informed us

about their Caribbean heritage. It was the same kind spirit that Dani, a sketch artist projected as he quickly but aptly drew caricatures for group members as we explored Old Havana. Despite the Centre for Advanced Studies of Cuba (Nanotechnology and Biotechnology Complex) being closed, the employees were kind enough to come in on their vacation and open the Centre for a brief tour.

While the days in Havana were lengthy with dusk not setting in until 8pm, daylight fatigue failed to tame our nocturnal spirits. From the Carnival on the first night to the Cabaret on the last, we made sure to maximize our stay. While the Cabaret showcased the dancing talent of Cubans, we also had the chance to display our skills at *La Casa de la Música*, which could easily be deemed the highlight of the trip. Even the Director, Professor Knight or Prof., as we fondly called him proved that he was not simply an accomplished academic and, in true patriotic form, we ensured that the entire crowd knew we were Trinbagonians as we shouted "Trinidad y Tobago" several times.

Our short sojourn at Memories Hotel and Resort, Varadero was blissful. Everyone yearned to stay a bit longer and we even wished that the trip could have started there. Some dared to ride a camel while others cooled down in the pool or beach and sampled food and drink at the many restaurants and bars. In true "Trini" style, our night ended with a beach party. It would be an exaggeration to say that we were the life of the event as the Cubans proved that they too not only love but know how to party.

Upon arrival in Panama, everyone sighed in relief because Wi-Fi was available to all and once again, our smart phones were useful for more than its camera feature. Still, I doubted whether anyone missed being connected to the wider world as Cuba had presented another world worthy of exploration. Naturally, no visit to Panama would be complete without seeing the Panama Canal which we did after touring the World Heritage Site, *el Casco Viejo*. Our last day was spent shopping but, even a day was insufficient as some of us missed the bus back to our hotel. Still, the group, comprised mainly of women would agree that shopping is always a welcome activity.

Cuba has carved a placed for itself in world history and our group from IIR was privileged to have experienced the country and its culture. Like other states, it faces many challenges but unlike some and perhaps ironically, Cuba's woes are directly linked to its attempt to chart a brighter future. Still, its slogan, "la patria es la humanidad" or fatherland is humanity remains a strong point for the island. The belief in self, fellowmen and country is a trait for which there is no substitute. José Martí once said that "the only thing a man ever owns outright is a place in his country." Cuban patriotism is easily recognizable and its people's hospitality is undeniable. During our short stay on the island, we never once felt out of place. Culture and that humane element eroded the language barrier as our untamed spirits effortlessly mingled as would old friends meeting for the first time in years.

In February 2015, CCRON launched a regional logo competition within Secondary Schools. This was signed in February 2015.

The Foreign Service Institute, Ministry of External Affairs, Republic of India and The Institute of International Relations, The UWI, St. Augustine signed on the June 5, 2015. The cooperation inter alia include:

- Exchange of information of structure and content of training programmes for diplomats;
- Identification of experts in mutually agreed areas.

The Ministry of Foreign Affairs of the United Mexican States through the Matías Romero Institute (IMR) and The University of the West Indies through the Diplomatic Academy of the Caribbean to carry out activities of collaboration in the field of diplomatic training under the principles of reciprocity and mutual benefits.
